Health Policy - Pay for Value - Impact on Health Information Technology

Presented by: Dr. Paul Mulhausen, *Telligen*

Dr. Mulhausen will discuss major themes in federal payment redesign, the federal health programs that incentivize value, and the potential implications for health information systems to support value-based payment.

Paul Mulhausen, M.D., M.H.S., is the Chief Medical Officer for Telligen, a population health management firm headquartered in West Des Moines, Iowa. Dr. Mulhausen received his medical degree from the University of Minnesota, a Masters in Health Sciences degree from Duke University and completed his postgraduate medical training in Geriatrics and Internal Medicine at the Duke University School of Medicine. He provides clinical input and support into Telligen's development of information management solutions, which include quality measure reporting, utilization management support, population health management solutions, and claims processing. He has extensive experience working with teams of IT experts in Federal Healthcare programs, including Medicare and Medicaid. He works closely with health policy experts and is a subject matter expert on the care of the elderly, disabled, and people who are dually eligible for Medicaid and Medicare. Dr. Mulhausen is currently a member of the Medicaid Information Technology Architecture (MITA) Governing Body and was recently recognized as one of the "2017 FedHealthIT100" for driving change and advancement in the Federal Health Information Technology Market.
