

Job Application Instructions

Applications must include:

1. A cover letter
2. A Resume / Curriculum Vitae
3. A statement explicitly addressing the key General, Essential and Desirable selection criteria
(as outlined in the JDF)

Statement Addressing the Selection Criteria

The essential criteria are located on the last page of the Job Description Form. The following is suggested to assist you in writing your statement:

- For each of the essential and desirable criteria, draw on your previous experience to write a brief statement that describes a situation in which you successfully utilised the skill or attribute to achieve a successful outcome.
- The examples should contain a description of the situation, an outline of the action you took, how the skill or attributes assisted you and the result of the action. In some instances, one statement may address more than one criterion, although this needs to be indicated.
- It is intended that the final statement addressing all criteria should be about half a page to a page per criterion, although the content is far more important than the volume.

Applications close at 10am WST, Monday 29th May, 2017. Incomplete or late applications cannot be accepted.
