

**Weekly Review October 9th - October 13th, 2017****Market Commentary Week ending 10/13/2017:**

- News that the ECB slowed down its expected time table for eliminating quantitative easing, and U.S. data showing a drop in the year-over-year inflation rate from 1.8% to 1.7%, resulted in a strengthening of fixed income markets towards the end of the week.
- Ten year Treasury yields declined 9 basis points to close at 2.27% by Friday.
- Ten year AAA muni rates declined by 6 basis points to finish the week at 1.96%.
- The ten-year muni to Treasury rate remained unchanged at 86%.
- The thirty-year ratio was also unchanged, remaining at 98%.
