**NOTE FROM JERRY:**

I attended the Mid Atlantic Fishery Management Council meeting last week in Virginia Beach. Highlights are as follows:

**APPROVES AMENDMENT TO PROTECT UNMANAGED FORAGE SPECIES:**

The Council approved an amendment to protect unmanaged forage species. The amendment would prohibit the development of new and expansion of existing directed commercial fisheries on a number of unmanaged forage species in Mid-Atlantic Federal waters. The prohibition would continue until the Council has had an opportunity to assess the available scientific information for these species and consider the potential impacts to existing fisheries, fishing communities, and the marine ecosystem. The council received 21,000 comments on the amendment.
