LEGISLATIVE UPDATE:

This week a new bill was introduced regarding striped bass. It's a modified gamefish bill for striped bass, ostensibly because the fish taken in that area are primarily hatchery raised fish. The bills primary sponsors are Rep. Billy Richardson, Rep. Jay Adams and Rep. Michael Wray.

Could not possess striped bass in that area by commercial fishermen, but OK to catch hook & line.

Here is the list of fisheries bills that were on last week's update. Two are scheduled for committee hearings: S-370, South Atlantic Federal Fisheries Resources by Senator Rabon. That's the resolution in opposition to catch shares, which NCFA supports. Committee meeting info below.

H-545: Marine Fisheries Advisory Committee Reforms: by Reps Boswell, Millis, Pittman, Clampitt, Dulin, Harrison, Speciale, & Steinburg

Would require the Marine Fisheries Commission to provide a resolution when the Commission rejects the recommendations of the advisors. Basis for this legislation is the action by the MFC in February when they rejected the overwhelming recommendations by 5 advisory committees to deny the shrimp Petition for Rulemaking.
