Peer review workshop for North Carolina blue crab stock assessment set

Staff with the N.C. Division of Marine Fisheries will hold a three-day, in-person workshop March 27-29 with scientists who are peer reviewing a draft assessment of the North Carolina blue crab stock.

The workshop will be held at the DoubleTree by Hilton Hotel New Bern Riverfront, 100 Middle St., New Bern.

The discussions begin at 1 p.m. on March 27, 9 a.m. on March 28, and 9 a.m. on March 29 and will be open to the public. The open sessions allow the public to observe the peer review process, but do not include a public comment period.

When deemed necessary, the committee will close the meeting to the public allow the peer reviewers to deliberate and complete a draft version of their peer review report.

A stock assessment is a scientific analysis that uses information gathered from commercial and recreational fishermen and data from on-the-water scientific sampling and observations to determine the health of a population and predict how that population may respond to different management measures.

A peer review is an evaluation of scientific work by independent and unbiased experts. A peer review of a fisheries stock assessment evaluates the validity of the data used, the appropriateness of the assessment model used and the rationale of any assumptions used to determine if the science conducted is adequate for use in fisheries management. Peer review scientists have not been involved in or had input into the development of the stock assessment and have no stake in its outcome.

The open, in-person peer review process is meant to foster communication between the peer reviewers and division stock assessment scientists and to improve public understanding of fisheries stock assessments.

Last year was the first year for Seafood Lobby Day, which we hope to make an annual event in conjunction with the Legislative Seafood Reception. The Reception was started several years ago by NC Watermen United (NCWU) and NCFA was invited a few years ago to participate. NCFA had the first Seafood Lobby Day last year, primarily to address H-867 which was basically a rewrite of the Fisheries Reform Act without any commercial fishing input.

MID ATLANTIC COUNCIL SEEKS ADVISORS

The Mid-Atlantic Fishery Management Council is soliciting applications from qualified individuals to serve on eight advisory panels. Advisory panels provide information and recommendations to the Council during the development of fishery management plans, amendments, specifications, and management measures. One of the chief responsibilities of advisory panels is the development of annual Fishery Performance Reports. These reports provide the Council and SSC with information about the factors that influenced fishing effort and catch within each fishery during the previous year.

Advisory panels are composed of individuals with diverse experience and interest in Mid-Atlantic fisheries. Members include commercial fishermen, recreational anglers, for-hire operators, dealers, scientists, environmentalists, and other members of the interested public. Most advisory panels meet 1-2 times per year. Members are compensated for travel and per diem expenses for all meetings. Individuals who are appointed to advisory panels serve for three-year terms. All current advisory panel members must reapply in order to be considered for reappointment.

The Council is accepting applications for the following advisory panels:

- Summer Flounder, Scup, and Black Sea Bass
- Mackerel, Squid, and Butterfish
- Surfclam and Ocean Quahog
- Tilefish
- Bluefish
- Ecosystem and Ocean Planning
- River Herring and Shad
- Dogfish (Jointly managed with New England Council)
