NCFA sent a letter last week to Governor Roy Cooper formally requesting that he remove all nine commissioners from the MFC and immediately begin the process of appointing a fair and equitable commission.

The letter states that such an action would fit very well in the Governor's "Hometown Strong" initiative for rural communities. In the press release announcing the Governor's initiative, he states "Helping rural North Carolina thrive is one of my top priorities."
