**GOVERNOR MCCRORY ANNOUNCES APPOINTMENTS TO MARINE FISHERIES COMMISSION:**

As noted in a Wednesday special update, the Governor has released the names of his latest appointments to the Marine Fisheries Commission. They are:

Mark Gorges was reappointed, but moved from a recreational seat to at-large;  
Chuck Laughridge was reappointed, but moved from an at-large position to recreational;  
Alison Willis was reappointed in a commercial seat;  
Brad Koury was appointed to an at-large seat.

#### PERSONAL NOTE FROM JERRY:

I was asked by media for comments on those appointments, and here is what I released:

Comments from Jerry Schill on the recent appointments to the Marine Fisheries Commission by Governor McCrory:

The appointments announced by Governor McCrory on November 2<sup>nd</sup> are astounding. Commissioners known to have violated the Open Meetings Laws of this state were reappointed. The two at-large seats were filled by recreational fishermen, meaning that the MFC will now be three from the commercial perspective, five recreational and one scientist. Rather than fill the at-large seats with individuals from a different viewpoint, such as a restaurant owner or seafood consumer, the Governor assures the continuing decimation of commercial fishing communities along our coast.

Coincidentally, a Petition for Rulemaking was filed on November 2<sup>nd</sup> before the Marine Fisheries Commission by the Southern Environmental Law Center, acting on behalf of the North Carolina Wildlife Federation, that would severely restrict shrimp in North Carolina. Or was it a coincidence? Will fishermen get a fair hearing on the issue now before a stacked Commission?

Commercial fishermen have always played the hand dealt by the good Lord. Hurricanes, noreasters, rogue waves are all part of the experience that gives them a toughness that few Americans have today. They have survived dealing with these adverse conditions, but the political storms are almost too much to bear. Hurricane Matthew is a cakewalk compared to the storm created by Governor McCrory.

And to clarify, this by no means is an endorsement of the Governor's opponent, as his documented positions also give one pause. Sad day when one needs to search for leadership that truly has an appreciation for the working folks of our state.

#### NORTH CAROLINA WILDLIFE FEDERATION FILES PETITION FOR RULEMAKING:

As noted in my comments above, shortly after the Governor's office sent out a notice about the Marine Fisheries Commission appointments, the North Carolina Wildlife Federation filed a Petition for Rulemaking with the Marine Fisheries Commission that would severely restrict shrimp trawling and other types of fishing practices in all state waters by declaring them Special Secondary Nursery Areas. They propose, for example, to restrict shrimp trawls to 90ft of headrope, only allow shrimp three days a week with no nighttime shrimp!
