The MAFMC will meet October 4-6, 2016 at the Stockton Seaview Hotel in Galloway, NJ to discuss the following agenda items:

- River Herring and Shad Committee will meet to develop Committee recommendations on whether to develop an amendment to add RH/S as Council-managed stocks
- Blueline Tilefish Framework – Meeting 1 to review background materials and approve range of alternatives
- Review previously set 2017 Spiny Dogfish specifications and consider any modifications if necessary in the Fishery (See Tab 2)
- Review Draft Environmental Assessment for Amendment 10 to the Highly Migratory Species (HMS) FMP
