CONTRACTOR MEMBER - Annual Membership Dues are \$2,000

Includes all prime and subcontractors. Contractor members are also subject to percentage dues at 1/10th of 1% on the value of any contract or subcontract awarded by any Florida government entity-local or state, with the first \$2 million of work per fiscal year being exempt from percentage dues. You are not subject to any dues on work you have on hand or are the low bidder on and awaiting award at the time you join. The maximum percentage dues on FDOT, airport, Expressway work, and local gov't work is \$25,000 per year.

ASSOCIATE MEMBER - Annual Membership Dues are \$2,500

Includes equipment dealers, material suppliers, engineering firms and design consultants. Material is defined as any item used in the actual construction of a project. Any other firm or individual with an interest in the transportation industry, except prime contractors and subs, are included in the associate member category.

AFFILIATE MEMBER – Annual Membership Dues are \$750

If you do not fall into either of the above categories, but have an interest in providing goods and services not utilized in the actual construction of a project, to those in the industry you would be an affiliate member. Attorneys, CPA's, insurance agents, bonding firms and individual claims consultants would fall under this category.
