While this is not a juried art show, the coordinators give consideration to each artist application to ensure variety of art and limit number of artists with similar product. The submission of application and payment does not guarantee acceptance or participation.
<b>Application Deadline:</b>	<b>SEPT. 1, 2018</b> \$20 late fee assessed for applications after Sept. 1 <sup>st</sup> , 2018.
<b>Background:</b>	The 40th Annual Afton Art in the Park will be celebrated in the historic village of Afton, MN, which is located along the scenic St. Croix River. This event will feature over 90 vendors of fine art and traditional craft. There will be live music, great food and a small business fair. Sponsored by Afton Area Business Association

<b>Advertising:</b>	Event heavily promoted in local newspapers, direct mailings, email list serves, flyers, media press releases, social media.
<b>Notification Of Participation:</b>	<p><b>AABA CANNOT GUARANTEE VENDOR PARTICIPATION OR ASSIGN VENDOR BOOTH UNTIL PAYMENT IS RECEIVED.</b></p> <p><b>Applicants selected to participate in Afton Art in the Park will receive an email <u>Acceptance Confirmation</u>.</b> If you do not have an email address, you will be called by phone.</p> <p>Applicants who are NOT selected will receive an email or phone call as soon as possible and the vendor fee will be refunded.</p>
<b>Booths:</b>	Spaces are pre-assigned 10 x 10. Each vendor must provide their own display materials, canopy / tent, table & chairs. Additional booth space is available for an added fee. Requests for placement will be considered, not guaranteed.
<b>Taxes:</b>	Each vendor must handle sales and collect sales tax as applicable. All participants must provide a completed copy of the Minnesota Department of Revenue, regardless if you are required to pay taxes or not. <b>Electrical:</b>	Artist booths do not include electricity. If needed, inquire with event manager.
<b>Insurance:</b>	All vendors that hold a Certificate of Liability Insurance should submit a copy. <u>If you do not have Liability Insurance, your signature on the application/waiver will be accepted in lieu of policy.</u>
<b>Photos:</b>	Please include 1-2 clear photos of your items for sale OR provide us with your website. Photos will be returned if an SASE is provided.
<b>Damages:</b>	Neither the Afton Area Business Association (AABA) nor any representative of the AABA shall be held responsible for any loss of or damage to equipment during the event. This includes damage incurred due to inclement weather.
<b>Security:</b>	Overnight security provided: FRI, Sept. 21 (11pm - 7am) & SAT Sept. 22 (11pm - 7am) AABA and Security Contractors are not responsible for lost or stolen goods.
<b>Parking:</b>	<b>NO Vendor Parking permitted</b> on St. Croix Trail or side streets of Park on SAT or SUN. We need to leave accessible parking for guests. Vehicles left on the grounds after 10am on show days will be towed. Vendor Parking sites will be assigned prior to event. Golf cart shuttle service will be available before and after the show hours for vendors.
