<b>Advertising:</b>	Event heavily promoted in local newspapers, direct mailings, email list serves, flyers, media press releases, social media and radio.
<b>Notification Of Participation:</b>	<p><b>AABA CANNOT GUARANTEE VENDOR PARTICIPATION OR ASSIGN VENDOR BOOTH UNTIL PAYMENT IS RECEIVED.</b></p> <p><b>Applicants selected to participate in Afton Art in the Park will receive an email <u>Acceptance Confirmation</u>.</b> If you do not have an email address, you will be called by phone.</p> <p>Applicants who are NOT selected will receive an email or phone call as soon as possible and the vendor fee will be refunded.</p>
<b>BOOTHS:</b>	Food vendors needing more than a 10x10 space will pay an additional \$100. Requests for placement will be considered, not guaranteed.
<b>TRASH:</b>	Food vendors must bring 2 large trash containers for their booth and provide their own garbage bags. There is a large dumpster available to empty trash containers into. (SW corner of park) Vendors must keep their area clean at all times!
<b>WATER:</b>	Limited availability. We are not able to offer direct access to every vendor.
<b>ELECTRICAL</b>	<p>Each Food concession must comply with the electrical standards as identified by the State of MN and Wash. County. State law requires annual electrical inspection prior to your first event of the season.</p> <p><b>Food vendors will be pre assigned an electrical outlet, based on the electrical needs of the vendor.</b> Vendors must have a back- up generator in case of power failure. AABA will not be responsible for loss of power.</p> <p><b>Food vendors must list power/electrical requests on application form.</b></p>
<b>Insurance:</b>	All Food vendors must hold a Certificate of Liability Insurance. Please send a copy via mail or email.
<b>Photos:</b>	Please provide your website or send images via email that contain clear photos of your tent or mobile truck that you will be using at this event.
<b>Damages:</b>	Neither the Afton Area Business Association (AABA) nor any representative of the AABA shall be held responsible for any loss of or damage to equipment during the event. This includes damage incurred due to inclement weather.

<b>Security:</b>	Overnight security provided: FRI, Sept. 22 (11pm - 7am) & SAT Sept. 23 (11pm - 7am) AABA and Security Contractors are not responsible for lost or stolen goods.
<b>Parking:</b>	<b>NO Vendor Parking permitted</b> on St. Croix Trail or side streets of Park on SAT or SUN. We need to leave accessible parking for guests. Vehicles left on the grounds after 10am on show days will be towed. Vendor Parking is available at Afton City Hall which is within walking distance, just north four blocks. Golf cart shuttle service will be available before, after and during the show hours.

<b>LICENSE:</b>	MUST POST CURRENT FOOD LICENSE IN BOOTH and submit copy prior to event.
