Fairfield Market on the Green:

Show Date: Sunday, June 11, 2017 10 AM – 4 PM. Rain or Shine.

The Fairfield Chamber of Commerce shopping event, Market on the Green is held on the Old Town Hall Green, corner of Old Post Road & Beach Road, Fairfield, CT. The event is free and open to the public. The set-up for exhibitors begins at 7AM, on Sunday, June 11th.

Entry Fee: (Checks Payable to the Fairfield Chamber of Commerce or credit card):

10' x 10' Basic: \$150 **10' x 10' Chamber Member: \$125**

10'x10' Prime location: add \$25 20'x10' Double (multiply single fee by 2 & deduct \$25)

Deadline for receiving entries: June 1, 2017. Checks will be returned if application is not accepted. There will be no cancellation refunds after June 3rd.

Eligibility: This will be a high-quality show. Vendors applying are asked to submit photos, web address, Esty shop or facebook page info so that we may review photos of your items. We reserve the right to limit the number of vendors exhibiting similar goods but do not guarantee exclusivity to any vendor.

Break-down: Please do not break-down before 4PM on Sunday.

Space Assignment: Exhibitors will be notified of their assigned space at sign in the morning of the event. Assigned spaces cannot be changed, transferred or sold.

Guidelines:

Nearby parking is available in front of Independence Hall or at Roger Sherman Elementary School. One vehicle per exhibitor. Absolutely no vendor parking in lot adjacent to Town Hall—not even for unloading and set up.

All exhibitors must be pre-registered.

All vendors are responsible for their own tables, chairs and tents.

Exhibitors are expected to keep their area clean.

The Chamber, its officers, members and representatives cannot be held responsible for any items missing or damaged.

The exhibitor is responsible for collecting Connecticut sales tax (6.35%).

Tents are required due to "RAIN Or SHINE" policy. All tends MUST have tent weights or be secured to the ground for safety purposes.

Exit 22
Right onto Round Hill Road
Cross Post Road/Route 1
Continue one block to stop sign
Town Hall is across the street on the right
