# DDC COMMENCES THE RECONSTRUCTION OF PUTNAM PLAZA TRIANGLE PROJECT

## Work to begin on/about Monday, March 26, 2018

- Mobilization of equipment and materials
- Installation of Tree Guards
- Storage and work area preparation

On/about Monday, March 26, 2018, the NYC Department of Design and Construction (DDC) will commence the Reconstruction of Putnam Plaza Triangle Project HWKP2029 in the Clinton Hill and Bedford-Stuyvesant neighborhoods of Brooklyn. This project will create a large, permanent public space within Putnam Avenue from Grand Avenue to Fulton Street, increasing the amount of open space for residents, shoppers, and transit users. Additional features include planting of additional trees, benches, movable tables and chairs, trash receptacles, green infrastructure elements, pedestrian Wayfinding signage and an NYC Bike Share station. The project is anticipated to be completed in the Winter 2019.

#### TRAFFIC/COMMUNITY IMPACTS:

During construction hours, you can expect the following:

- Increased levels of dust, noise and heavy equipment.
- Pedestrian access to buildings will be maintained at all times
- Street closures may be required;
   Vehicular travel lane closures will be required, as well as detours. Warning signs will be posted in advance.
- Parking and driveway/loading dock restrictions, signs will be posted within the affected areas.
- Emergency vehicle access and pedestrian access to sidewalk and buildings will be maintained at all times.

#### Schedule:

Fall 2017 - Summer 2019

#### Work hours:

7:00 am to 6:00 pm Monday thru Friday, and 8:00 am to 6:00 pm Saturday.

#### **Water Service Interruptions**

During the course of the project there will be service interruptions. To allow water replacement, the existing water service must be shut off by closing the valves at either end of the section. Advance notice will be given for all planned interruptions. Water service will be restored at the end the work day.

#### **SPECIAL NEEDS:**

The DDC staff will work specifically with individuals that have special needs who may be uniquely impacted by the project. Please reach out to the project's Resident Engineer, as soon as possible, to make them aware of your situation. DDC will work with you to attempt to minimize the inconvenience as much as possible.
