

POWER OF ATTORNEY FOR THE SALE OF CHAMETZ 5778 / 2018

Ideally, transfer of Power of Attorney should be done in person, and JCAB members who live in the Atlantic Beach area are strongly encouraged to do so (see schedule on back). Where that is absolutely not possible, this PoA form may be faxed to the JCAB office (516-371-5373) by 9:30 AM on Thursday, March 29th.

I, the undersigned, fully empower and permit Rabbi Ari Perl, or his duly appointed agent, to act in my place and stead, and in my behalf to sell all "chametz" possessed by me (knowingly or unknowingly) as defined by Torah and Rabbinic Law. Choosing this option essentially turns your entire home into one large 'Chametz Cabinet' which can be closed up for Pesach, thereby eliminating the need to move chametz to a specified location within the home.

Important Note: Arrangements for the Sale of Chametz can be made *before* your Pesach preparation/cleaning is completed and before you have actually moved your chametz to its Pesach storage area. Because the actual sale to a gentile does not take place until right before pesach, you may continue to consume your Chametz even after the Power of Attorney form has been filled out and handed over. **There is no need to wait until after you've cleaned for Pesach** to transfer Power of Attorney!
