Leibniz-DAAD Postdoc Research Fellowships: Deadline March 9, 2017



The 2017 **deadline** for applications to the **Leibniz-DAAD Research Fellowship** will be **March 9th**.

This program offers recent postdocs (thesis defence no earlier than Jan. 1, 2015) the opportunity to apply for a research fellowship to support a 12-month research stay at one of the 91 independent research institutions that make up the [Leibniz Association](#).

In order to be eligible to apply, applicants must not hold German citizenship, have an outstanding research record, hold a PhD or equivalent and an excellent working knowledge of English.

This fellowship provides recipients with a monthly stipend of 2,000 euros, full insurance coverage and a German language course.

Postdoctoral Researchers International Mobility Experience (P.R.I.M.E.)

The DAAD's "Postdoctoral Researchers International Mobility Experience" (P.R.I.M.E.) supports the international mobility of postdoctoral researchers by temporary positions at German universities in place of conventional scholarships.

Postdoctoral researchers of all nationalities, who see their long-term career perspectives in Germany, will be given the opportunity to combine employment at a German university with a research stay abroad.

The P.R.I.M.E. program, funded by the German Federal Ministry of Education and Research and the European Union (EU/FP7/Marie Curie Actions/COFUND), provides participants with an 18-month work contract with a German university; the first 12 months are spent at a university or research institution outside of Germany with the final 6 months (re-integration phase) carried out at a German university.

Deadline and How To Apply

The **deadline** for applications is **May 15, 2017** with adjudication of applications taking place in October 2017. The earliest starting date for funding is January 1, 2018.
