

Presenter Biographies

Mary Mazzio, JD, (Keynote Speaker), an award-winning documentary film director, Olympic athlete, and former law firm partner, is Founder & CEO of 50 Eggs, Inc., an independent film production company dedicated to making socially impactful films. Mary wrote, directed and produced the highly-acclaimed films *Underwater Dreams*, *TEN9EIGHT*, *The Apple Pushers*, *A Hero for Daisy*, *Contrarian*, *Apple Pie*, and *Lemonade Stories*. Her newest documentary film, *I AM JANE DOE*, narrated by Academy Award nominee, Jessica Chastain has been called “a gripping legal thriller” (*Esquire*) and “a powerful call to action” (*The Los Angeles Times*) and chronicles the epic legal battle that several American mothers are waging on behalf of their middle school daughters, victims of sex trafficking on the classified advertising website *Backpage.com*. The companion film, and animated short called *I AM LITTLE RED*, premiered at an event hosted by the US Department of Education and the US Department of Health and Human Services. Ms. Mazzio is graduate of Mount Holyoke College and Georgetown Law School.

Jessica Soto, JD, (Keynote Speaker), served on the Ropes & Gray legal team representing human trafficking survivors in Massachusetts and is featured in the film *I AM JANE DOE*. Ms. Soto joined the Ropes & Gray litigation department as an associate in 2012 and is a member of the firm’s government enforcement practice group. Jessica’s *pro bono* practice includes representing indigent defendants in federal criminal cases through the firm’s participation in the Criminal Justice Act program and representing human trafficking survivors in federal civil cases. Ms. Soto is a graduate of Yale University and Columbia University School of Law.

Denise Edwards, MPP, (Plenary Speaker), is director of government affairs for National Children’s Alliance (NCA). As director of government affairs, Denise develops, coordinates and leads all federal legislative and political strategies for NCA and its members, including strategies to expand the use and awareness of CACs in legislation and agency policy. Prior to her tenure with NCA, Denise served as manager of government affairs for Dunkin’ Brands, Inc., representing the company and its more than 16,000 small business franchises before Congress and State/Local governments. Denise began her Washington career working in the U.S. House of Representatives serving on the staff of several members, including as deputy chief of staff and legislative director for Rep. Bud Cramer. Denise is a graduate of Baylor University, with a master’s in Public Policy Administration and a bachelor’s in Business Administration with a focus on financial planning.

Sue Ascione, MS, joined NRCAC as a Training Specialist in 2016 and has served over 30 years in the field of family violence as a direct service provider to victims of child abuse and domestic violence and in leadership positions at child-serving nonprofit organizations in Northwestern Pennsylvania. Ms. Ascione served 16 years as the Executive Director of the Children’s Advocacy Center (CAC) in Lawrence County, PA. She has been a mentor, trainer, and consultant to many emerging and developing CACs and multidisciplinary teams to identify challenges, barriers, and organizational development needs to plan for changes necessary for quality improvement. Stephanie Block, Ph.D, is Assistant Professor in Applied Developmental Psychology at the University of Massachusetts, Lowell. She teaches graduate and undergraduate courses in Child Maltreatment and Psychology and Law. She received her Ph.D. from the University of California, Davis, and was a NICHD postdoctoral fellow with the Center for Developmental Science at the University of North Carolina at Chapel Hill. During her postdoc she was also affiliated with the Injury Prevention Research Center where

she received public health training and conducted research in the primary prevention of child maltreatment. Dr. Block serves on the Executive Committee for the American Psychological Association's Division on Child and Family Policy's Section on Child Maltreatment. Her research has broadly focused on children in the legal system, the effects of trauma on children's wellbeing, and memory for emotional events. Stephanie has consulted with several district attorney offices and the Innocence Project on issues related to children's eyewitness testimony and their experiences in court. Christopher Kelly, JD, is the Director of the Digital Evidence Laboratory for the Office of the Massachusetts Attorney General where he leads a team of analysts conducting digital forensic examinations of technical evidence in the course of criminal investigations. He previously served as Managing Attorney of the Cyber Crime Division there where he prosecuted cyber offenses. Prior to working at the Attorney General's Office, Mr. Kelly worked for the Suffolk County District Attorney's Office, where he built and ran the current Computer Forensic Laboratory; there he prosecuted cybercrime cases and worked on the digital aspects of criminal investigations. Mr. Kelly serves as an instructor and performs curriculum development for the United States Secret service and is an adjunct professor of digital forensics at Bunker Hill Community College. Mr. Kelly holds several digital forensic certifications, is a regular speaker on topics related to digital forensics and cybercrime investigations, and belongs to several professional associations, including the Accreditation Task Group for the National Institute of Standards in Technology's Digital Evidence. He also sits on the editorial board for the Journal of Digital Investigation. Mr. Kelly earned bachelor's degrees in psychology and political science from Boston University, and his law degree from Suffolk University Law School. **Workshop:** *Technology, Child Pornography, and Trafficking.*

Julie Kenniston, MSW, LISW, is a Program Manager for the National Criminal Justice Training Program of Fox Valley Technical College. She presents nationally and internationally on forensic interviewing. She is a faculty member for the American Professional Society on the Abuse of Children (APSAC) and Ohio Attorney General's Finding Words forensic interview courses. Ms. Kenniston coordinated the Forensic Training Institute for The Childhood Trust and now manages the updated Child Forensic Interviewing program. She co-chairs the APSAC forensic interviewer committee and chairs the committee updating guidelines regarding the use of interview aids in forensic interviews. She has conducted over 3,000 forensic interviews and currently conducts interviews for the Southwest Ohio ICAC Task Force. Kelly Kinnish, Ph.D, is the Director of Clinical Services at the Georgia Center for Child Advocacy in Atlanta, GA, where she oversees the Center's clinical service programs to sexually abused and traumatized children and children engaging in problematic sexual behaviors. She is also the Director of Project Intersect, a SAMHSA-funded program of the National Child Traumatic Stress Network that targets the mental health needs of Commercially Sexually Exploited Children. Project Intersect supports clinical services to CSEC-identified clients at the Georgia Center and also supports the training of a network of providers throughout the state in trauma-focused evidence-based practices. Dr. Kinnish received her PhD in Psychology (Clinical-Child), from the University of Utah and completed her internship and post-doctoral training at the University of Miami (FL).
