

Applying for a Co-op Work Permit Online

This is not a legal document and information may change without notice. Always refer to <http://www.cic.gc.ca> for the most up-to-date information, or visit International Education Office for assistance.

To apply online for a Co-op Work Permit online, you need to prepare required documents in an acceptable format (PDF, WORD or JPEG) and upload them from your MyCIC account.

Check your study permit expiry date before applying for a co-op work permit since the work permit can only be issued up to your study permit expiry date. If your study permit will expire soon, see your International Student Advisor to learn how you can apply for a study permit and a co-op work permit together.

Application Form, Supporting Documents and Fee (additional documents may be requested):

- **IMM5710** (Application to Change Conditions, Extend my Stay or Remain in Canada as a Worker)
- **Co-op Letter**
- Option -- **official transcript** issued by Centennial College
- **Copy of Passport** (Scanned copy of your photo page and all other pages with stamps and visas. Also include a copy of your current study permit.)
- **Digital Photo**
- **Proof of medical exam** (if applicable):
 - A medical exam may be required depending on your country of residence from the past 12 months and your program of study. Your medical exam results are valid for 12 months once it is done.
- **Fee** - \$0 (There is no fee for a coop work permit application.)

1. Current mailing address	This is the address where your permit will be mailed. Make sure to enter a valid address where your documents will not be lost.
