

Dear College Hill Resident;

The College Hill Neighborhood Association is working with key stakeholders on College Hill to develop a parking plan to address parking concerns around the proposed Lafayette College Housing expansion.

We have developed a preliminary plan, based upon current feedback from area neighbors and conversations with some retailers. We have posted the preliminary plan on our website (www.eastonchna.org).

But, our goal is to hear from all key parties in developing a solid plan that addresses as many concerns as possible. We ask that you take a look at the preliminary plan initially and then provide the following feedback.

The primary focus of the meeting will be to gather information about parking concerns, suggestions and issues surrounding the proposed expansion of Lafayette College's housing program into the College Hill neighborhood on McCartney street as well as Cattell street in order to "evolve its admission program into a 'need blind' admissions process and diversify its student body."

As an FYI, CHNA will be providing an updated presentation on the proposed Lafayette Expansion in our Annual Meeting on Tuesday March 21st at 7pm at the College Hill Presbyterian Church at 501 Brodhead Street (corner of Monroe and Brodhead streets).

The secondary focus of the meeting is to gather information on other parking issues outside of the expansion to begin to examine ways to address those concerns. (i.e., parking congestion during Lafayette Football games, Easton/P'burg game, etc.)

We ask you to provide personal experiences specific to parking. Specifically, we would like to hear from residents who have (or have not) experienced parking issues with Lafayette College students in and around the neighborhood area of the proposed expansion.

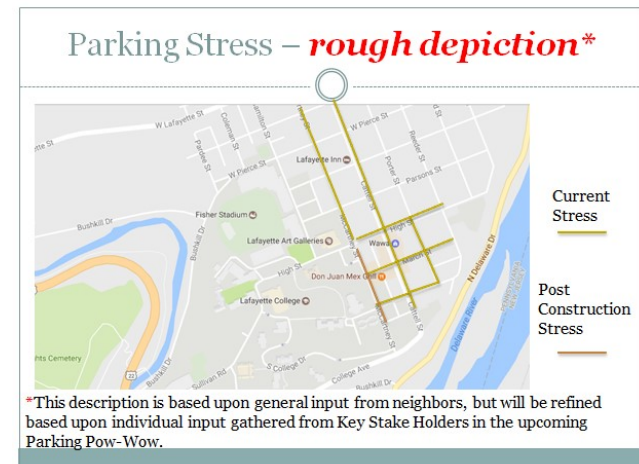
With this information we hope to begin to identify the areas of stress from first-hand accounts of issues. Second hand accounts (i.e., "I heard that John Doe has students parking in front of his house all the time") are less helpful in developing an empirical map of the parking stress surrounding the project.

How to provide input

We have arranged for an email address to be dedicated to providing input for first-hand issues, concerns and suggestions for these two objectives.

In order to provide our representatives some ability to separate emails on the primary versus secondary goals of the Parking Pow-wow, we ask that you include that information in the subject line of your email.

We also ask that you provide your address in the body of the email, so we can begin to assemble a "stress map" for both types of issues.
