With the long anticipated adoption of the 2012 editions of NFPA 101 and NFPA 99 occurring last year, there are changes to the requirement that health care facilities must comply with. This session will define exactly what CMS adopted and review key provisions from the 2012 editions of both codes. Topics to be covered include:

NFPA 101 – 2012 Edition - Suite Provisions, Corridor Clutter, Alcohol-Based Hand Rub Dispensers, Chapter 43 – Building Rehabilitation, High-rise Sprinklers in existing high-rise buildings, Sprinkler System Impairments/Shutdown and Cooking Facilities.

NFPA 99 – 2012 Edition - Complete re-write and re-organization, Risk Based Approach, Wet Procedure Locations, Smoke venting from Operating Rooms, Cylinder Storage Requirements and Power strips.
