Dear Community Leader:

Thank you for your interest in Leadership Riverside, a signature program of the Greater Riverside Chambers of Commerce. The Leadership Riverside program is looking for leaders and decision-makers in business, service, government, and education to apply for the incoming Class of 2018. Unlike any general skills development program, Leadership Riverside looks for those individuals who have attained skills and positions of leadership and equips them with the knowledge and awareness of those forces and issues that shape our community's future. Upon graduation and beyond the class project, each class member is expected to utilize the skills and information gained in this program to work and advocate for the betterment of the region.

Through facilitated sessions and conversations with policy makers, industry experts and visionary leaders, you will get a unique opportunity to dissect and distill the critical challenges facing our city and region, while experiencing a civic leadership framework to enhance personal and professional development. This intensive series of classes and workshops will give you the breadth and depth of knowledge and relationships to be effective as an advocate, policy influencer and maker.

This 10-month program empowers decision-makers of local businesses, government, non-profit organizations, schools and universities, with the knowledge to address critical regional issues, such as economic development; education; health care; public safety; social services; arts and culture, and others. Classes consist of approximately 20-25 dynamic individuals who are drawn from different backgrounds and philosophical perspectives who upon graduating, go on to contribute to Riverside's economic and cultural vitality.

Leadership Riverside is currently accepting applications for the Class of 2018 until **Monday, June 26, 2017 at 5 PM**. Class sessions will commence in September 2017, with an orientation luncheon scheduled in August. Attached is more information on the program; including requirements, tuition costs, a tentative schedule of sessions and a program application. **Qualified applicants must be available for a brief interview on either Wednesday, July 19, 2017 (8:00 AM - 1:30 PM) or Thursday, July 20, 2017 (11:40 AM - 4:10 PM)**. It is recommended that the qualified applicants wait another year if the candidate cannot commit to all program events and class sessions.

# LEADERSHIP RIVERSIDE CLASS OF 2018 FACT SHEET

## PROGRAM

Since 1986, Leadership Riverside has strengthened the community by developing and empowering today's local leaders. The program includes 10 monthly, full-day sessions devoted to key community issues at locations throughout Riverside. Participants get an in-depth knowledge of the region and build strong and lasting relationships between participants and the organizations they encounter.

The program brings together a diverse group of participants. Our classes consist of about 20-25 dynamic individuals in businesses, government, and non-profit organizations, schools and universities who are drawn from diverse backgrounds and philosophical perspectives.

Through facilitated sessions and conversations with policymakers, industry experts and thought leaders, you will enhance your understanding of issues impacting Riverside while advancing your personal, professional and civic development. You will join the ranks of our more than 500 alumni who have gone on to serve on boards and commissions, representing the voice of the greater Riverside region.

## TIME COMMITMENT

The Class of 2018 meets every first Friday from September 2017 to June 2018, with graduation in June 2018. In some instances, special circumstances require an alternative week to be scheduled. A tentative schedule is included below for your reference. In order to accomplish Leadership Riverside's objectives, the full participation of each individual is essential. Expected participation includes all sessions on the attached schedule as well as additional time outside of the sessions, as needed, to complete a service learning group project. Unforeseen emergencies are recognized, but it is recommended that the qualified applicants wait another year if the candidate cannot commit to all program events and class sessions.

## FINANCIAL COMMITMENT

The tuition for the Leadership Riverside Class of 2018 is **\$1,250**. The employer, another sponsoring organization, or the participant may pay tuition. **Tuition is expected prior to the first session in September.** Other payment options will be addressed by the selection committee.

## SELECTION CRITERIA

Applicants to Leadership Riverside may apply either on an individual basis or be nominated by a Riverside business or organization.

Through a competitive application review and interview process, the Leadership Riverside Steering Committee will select 20-25 participants. In order to ensure the broadest possible representation of professional and community experiences, the number of participants from any one profession or area of interest may be limited.

Applicants are ineligible to apply if currently running for an elected position or will be running during the course of the program. To be considered for the program, the applicant must be available for an interview on either Wednesday, July 19, 2017 (8:00 AM - 1:30 PM) or Thursday, July 20, 2017 (11:40 AM - 4:10 PM).

The ideal candidate has:

- Held positions that demonstrate leadership in professional and civic/volunteer endeavors.
- Aspirations to serve on boards or other leadership roles in the community.
- Strong references.
- The probability of remaining in the greater Riverside area for at least five years after completion of the program.
