Working at a military facility?

There are new requirements!

EM385 requires all Competent Persons who have employees who work at height, to attend a 24-hour class. Federal enforcement of training requirement will begin **September 1, 2016**. Section 21 is significantly different from the current OSHA Subpart M and ANSI A10.32 requirements

This course is designed for military facilities and site supervisors who must also serve as the competent person required by **OSHA 1926.32(f), 1926.500, 1910, ANSI/ASSE Z359.2** and **EM385-1-1** standards.

Participants are assigned tasks which require evaluation for fall hazards. The tasks are described using real-life site photos. The training provides detailed coverage of the Fall Prevention & Protection Supervisor Training course materials and program topics. The course also supplies the participant with the knowledge and skills to perform the annual inspection and record keeping.

The training provides experience, methodology and in-depth look at all standards (ANSI & CSA) and regulations (OSHA) covering inspection of personal fall arrest systems.

From I-93S in Concord: Take Exit 15 E to I-393 East. Take Exit 3 to Route 106 and head Right onto 106-South.

Proceed 1 mile, past the Steeplegate Mall. The ABC Chapter Office & Education Center is on the Right at the corner of Route 106 and Chenell Drive.

From I-93N in Concord: Take Exit 13. Proceed right onto Route 3-NoRouteh; Manchester Street. Move into the left lane and take the first left onto Old Turnpike Road; cross over Airport Road and continue on Regional Drive to Route 106. At the lights turn Right onto Route 106. We are at the next intersection. The ABC Chapter Office & Education Center is on the Right at the corner of Route 106 and Chenell Drive.

From the Seacoast: Take Route 4-West to I-393 West. Take the Route 106-South exit on your Left. Proceed 1 mile, past the Steeplegate Mall. The ABC Chapter Office & Education Center is on the Right at the corner of Route 106 and Chenell Drive.
