## 2018 Summer Pickleball

**ACTIVITY NUMBER:** 21203

**DESCRIPTION:** Play pickleball outdoors this summer season at the platform courts located at **Loughlin Avenue Park**. This is a co-ed program for adults. Court time is shared amongst all those registered to play. All participants must be registered. Drop-in is not offered for Wednesdays at Loughlin Avenue Park.

### REGISTRATION:

- **Online: Monday, April 23** - Online registration is only available to Greenwich residents. To register online go to: [www.greenwichct.org/webtrac](http://www.greenwichct.org/webtrac) and select "Activity Registration."
- **Mail-in and in-person: Monday, May 7** - application should not be postmarked earlier than May 7. In person registration is accepted at the Parks and Recreation Office. Non-residents may sign-up starting Monday, May 7. Registration remains open until the program is filled. Space is limited and registration is first come, first serve.

**Proof of Greenwich residency is required once each calendar year for all Parks and Recreation programs.** The Primary account holder is required to provide two current proofs of Greenwich residence. Acceptable forms of proofs with resident name and Greenwich address are as follows: residential lease, utility bill (Gas, Electric, Water, Oil), phone, internet and/or TV service bill (No Cell/Wireless Phone Bills), credit card or bank statement (No Mortgage Statement) or valid Driver's License or Connecticut State ID card. **ALL participants**, under 25, require a birth certificate or passport on file. **All non-residents must provide identification and proof of address.**
