**REGISTRATION:** Begins online April 2, 2018. Online registration is only available to Greenwich residents. To register online go to: [www.greenwichct.org/webtrac](http://www.greenwichct.org/webtrac) and select “Activity Registration”. Mail-in registration begins April 16, 2018. In-person registration and registration for non-residents begins May 7, 2018 at the Town Hall Parks and Recreation Office (Monday – Friday 8:00 AM – 4:00 PM) until classes are filled. **If not yet provided in 2018, residents must provide proof of residency and non-residents must provide identification and proof of address.** Resident primary addressee must provide two proofs and any household member 25 years or older must provide one proof for the purchase of passes, activities, facilities or tickets. Proofs for Greenwich residents may include: residential lease, utility bill (Gas, electric, water, oil), credit card bill, bank statement (not mortgage), cable bill, phone bill (not cell), driver’s license, DMV ID. Proofs of Greenwich residential address must be current and show resident name.

**Completed registration form & payment must be received in the Parks and Recreation Office (2<sup>nd</sup> Fl, Town Hall) 5 business days prior to clinic start date.** All classes will be held at the Bruce Park Tennis Courts; fees are for one week sessions (Monday –Thursday). **Please bring one new can of tennis balls to the first day of weekly session.**
