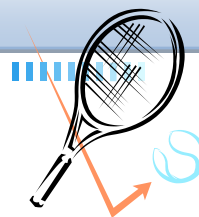

# Platform Tennis



**ACTIVITY NUMBER:** 41201

**DESCRIPTION:** MEMBERSHIP is required to play paddle tennis on the platform courts. Players who purchase a seasonal rental for \$325.00 will be given 2 one hour time slots per week. Reservations must be made at the time of purchase for the entire season.

**REGISTRATION:** Starts Monday, September 26, 2016 online. Online registration is only available to Greenwich residents. To register online go to [www.greenwichct.org/webtrac](http://www.greenwichct.org/webtrac) and select "Activity Registration." Mail-in registration begins Monday, October 10. Application should not be postmarked earlier than October 10. In-person registration at the Parks and Recreation Office begins on Monday, October 17. Non-residents may sign-up starting October 17. If not yet provided this year, residents must provide proof of residency and non-residents must provide identification and proof of address. *Proofs for Greenwich residents may include: residential lease, credit card bill, bank statement (not mortgage), utility bill (Gas, electric, water, oil), cable bill, phone bill (not cell), driver's license, DMV ID. Proofs of Greenwich residential address must be current and show resident name.*

**There is a \$25.00 seasonal fee for residents 65 and older – daytime use only - 2 senior park passes required to make reservations – registration form must be filled out in order to be given access to the courts.**

**SEASON:** The courts will be open November 12, 2016 through April 8, 2017.

We accept Visa, MasterCard, and Discover credit cards at the Town Hall Parks and Recreation Office & for online registration. **There are no refunds and we do not pro-rate fees. Requests for credit will only be considered if received in writing prior to the start of the program. There is a \$15.00 administrative fee for credits and a \$25.00 fee for any returned checks.**

**COURT LOCATION:** Loughlin Avenue, Cos Cob (Court 1 is closest to the field/playground; Court 2 is closest to the tennis courts). Lights are on 7 days per week from dusk to 9:00 pm. Reservations start on the hour 9:00 am – 8:00 pm.

## COMMENTS:

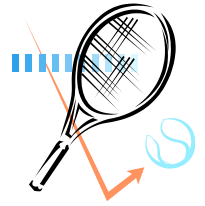
- Players must wear tennis shoes while on the courts.
- During open time players are asked to limit play to one hour if others are waiting.
- During times of snow, the courts are low priority and will be cleared after sidewalks and other access ways. The courts will not be cleared on weekends. Please do not attempt to clear them as the surface may become damaged or unsafe. 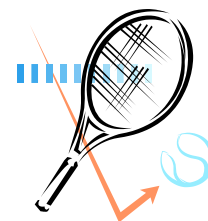
- **Season Renters** may reserve two 1-hour time slots per week (consecutive hours permitted week days, during daylight hours).
- **Senior Citizen residents** with park passes may reserve courts bi-weekly (call or e-mail) for two consecutive weeks. The reservations are for daylight hours only. The calendar week begins on a Saturday and continues through the following Friday. **ALL SENIOR PARK PASS CARD NUMBERS MUST BE GIVEN WHEN MAKING RESERVATIONS.** A season rental **must** be purchased to play during the evening hours and to have secured court times for the duration of the season. Each reservation will require a minimum of two cards in effect for the day of the reserved time slot.
- All reservations and cancellations may be made either by phone or email between the hours of 10:00 am - 2:30 pm Monday thru Wednesday. Phone: 203-618-7649, email: [Recreation@greenwichct.org](mailto:Recreation@greenwichct.org). Reservations will not be taken the weeks of Thanksgiving and Christmas.
- Failure to arrive within 10 minutes of a reserved time slot will result in the forfeiture of the reservation, with the slot reverting to "open time".
- The scheduled reserved and open time slots will be posted at the courts and sent via email to all members.
- During open time, players are asked to limit play to one hour if others are waiting.
- The reservation phone line will close April 5, 2017. The last day of reserved use of courts will be April 8, 2017. The **season may be extended** if the courts are closed due to excessive loss of court time. (snow/ice covered).
- Adult season renters or senior park pass holders may bring children ages 13 and under to play as long as the children have valid park passes.
- The courts will be locked. Players will be responsible for locking up after use. The combination may be changed from time to time. Anyone found giving the combination to a non-registered player, will forfeit their use of the courts and no refunds will be issued.
- Any lost court time due to snow, rain, or repairs, can be made up by calling the reservation line; 203-618-7649 or emailing [Recreation@greenwichct.org](mailto:Recreation@greenwichct.org). A reservation/rental must have been made in order for the time to be made up.
- Players must have some form of identification and must make it available when requested by Recreation Staff.
- The Recreation Division reserves the right to reserve time slots for instructional purposes, tournaments, league play, and Saturday/Sunday socials.
- Only players wearing tennis shoes are permitted on the courts.
- Please contact us whenever there is a light out or a problem at the courts that we should be made aware of.

**Please Note:** During times of snow the courts are low priority and will be cleared after sidewalks and other access ways. The courts will not be cleared on weekends. Please bear with us and do not attempt to clear the courts as the surface may become damaged or unsafe. 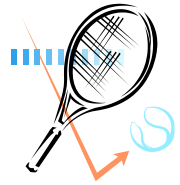
