

FAFSA CHECKLIST

Class of 2018

What will I need to file the 2018/19 FAFSA?

- FSA ID - Student's electronic signature - create an FSA ID prior to FAFSA submission at fsaid.ed.gov
- FSA ID - One parent's electronic signature - create an FSA ID prior to FAFSA submission at fsaid.ed.gov
- Your Social Security Number
- Your Parents' Social Security numbers if you are providing parent information
- Your driver's license number if you have one
- Your Alien Registration Number if you are not a U.S. citizen
- 2016 Federal tax information or tax returns including IRS W-2 information, for you (and your spouse if you are married), and for your parents if you are providing parent information
- Records of your untaxed income, such as child support received, interest income, and veterans non-education benefits for you and for your parents if you are providing parent information
- Information on cash, savings and checking account balances, investments including real estate but not including the home in which you live; and business and farm assets for you and for your parents if you are providing parent information
- File your FAFSA at www.fafsa.gov

FIVE REASONS WHY FILLING OUT THE FAFSA IS A REALLY GOOD IDEA:

1 It's how the government and colleges decide your financial need and award institutional aid in some cases for all income levels.

2 If you have all of your documents, it only takes approximately 30 minutes, and you can do it online for FREE! (See checklist page 2)

3 You might be eligible for federal grants, which you don't have to pay back! (See below)

4 Even if you don't think you'll need a loan, it can't hurt to have a backup plan in place. If you do borrow, only borrow what you need. Loans must be paid back.

5 Work-study jobs are mostly on campus, and you become qualified to apply based on your FAFSA information.

TEACH Grant	(up to \$4,000)
Iraq and Afghanistan Service Grant	(up to \$5,382)
Direct Subsidized Loan	(up to \$5,500)
Direct Unsubsidized Loan	(up to \$20,500)
Federal Perkins Loan	(up to \$5,500)
Direct PLUS Loan for Parents	(cost minus other aid)

Here's Why You Should Create a LOSFA Student Hub Account:

- The TOPS Tracker shows progress toward a TOPS award.
- ACT scores and TOPS Core GPA are displayed.
- Parent accounts may also be created.
- After graduation, TOPS eligibility notices, award letters, and Rights and Responsibilities will be posted in the Student Hub.
- Upon entry into postsecondary education, notices and TOPS status updates will be in the Student Hub.





CLASS OF 2018 FINANCIAL AID ACCESS POLICY

LOUISIANA REQUIRES PUBLIC SCHOOL STUDENTS GRADUATING SPRING 2018 AND BEYOND TO TAKE ONE OF THE FOLLOWING STEPS AS PART OF THEIR INDIVIDUAL GRADUATION PLAN:

- ➡ Complete the FAFSA at [fasfa.gov](https://www.fafsa.gov); or
- ➡ Complete the Louisiana TOPS form; or
- ➡ A parent or legal custodian, or a student legally emancipated or of the legal age of majority, may certify a waiver in writing to the LEA (sample: non-participation LEA form/Letter); or
- ➡ Receive a waiver through the district hardship waiver process

11 COMMON FAFSA MISTAKES

1. **NOT COMPLETING THE FAFSA** – If you don't complete the FAFSA, you could lose out on thousands of dollars to help you pay for college.
2. **NOT USING THE CORRECT WEBSITE** – The official FAFSA website is [fasfa.gov](https://www.fafsa.gov). Never pay to complete the FAFSA!
3. **NOT GETTING AN FSA ID AHEAD OF TIME** – Create your FSA ID early to avoid any delays.
4. **WAITING TO FILL OUT THE FAFSA** – Some financial aid is awarded on a first-come, first-served basis so get it done ASAP!
5. **NOT FILING BY THE DEADLINE** – Each school sets its own FAFSA deadline so be sure to check with your school.
6. **NOT USING YOUR FSA ID TO START THE FAFSA** – Sign in the FAFSA with your FSA ID to prevent common errors and for easier electronic signing.
7. **NOT READING DEFINITIONS CAREFULLY** – Take your time to read carefully to avoid processing delays.
8. **INPUTTING INCORRECT INFORMATION** – Be sure to enter your full name as it appears on your Social Security card and triple check your SSN.
9. **NOT REPORTING PARENT INFORMATION** – Dependency guidelines are determined by Congress, not IRS. Answer all questions on FAFSA carefully.
10. **LISTING ONLY ONE COLLEGE** – List all colleges you are considering even if you haven't applied or been accepted yet.
11. **NOT SIGNING THE FAFSA** – An unsigned FAFSA is incomplete. Sign electronically with your FSA ID which is faster than mailing a signature page.
