#### **Guest Presentation by Jill Althage (15 minutes)**

- Should 2U join the Illinois Gun Violence Prevention Coalition?
  - If approved, our name would be on IGVPC's brochure as an org that supports gun violence prevention (our name would not be on the website)
  - Support from a few other congregants who are involved in the org
  - Brady Campaign to Prevent Gun Violence and Illinois Council Against Handgun Violence are other orgs worth considering as well
  - Perspective from some congregants that they are hesitant to do anything that would put people of color in prison (if supporting IGVPC were to mean more arrests for people of color who have guns)
  - The coalition works against gun dealers and NRA
  - Want to give opportunities for congregants to take action versus just being frustrated about all the gun violence
  - Is there a way to represent 2U without necessarily saying all people within the community support the coalition?
  - There are a lot of organizations taking part in conversations about gun violence prevention
  - Concerns from some individuals in social justice regarding affiliating with organization that works with police due to police violence
  - Leadership of SJC has talked on individual basis but not as a group
  - Adam No prior vote (congregational statement) regarding gun violence, so what would/could the board say without the congregation having a voice?
  - No persons of color are voting members of the board
  - Adam recommends having a congregational meeting
  - Meeting for January/February 2017 checking with the ED of Illinois Council Against Handgun Violence Colleen Daley to see regarding her availability

#### Staff Reports Review and Discussion (15 minutes) - Rev Robersmith & Andrew

- Minister's Report
  - Need to bring together a group for strategic planning
  - o Wants to bring together a team to reimagine how we do leadership development
  - Cabinets for music and worship storage behind chancel
    - Company willing to donate the cabinets (see attachment)
    - Lew and some others to donate the labor
    - Cabinets could be upgraded to better match the woodwork
    - Motion: To reallocate the funds from Jen Duston's memorial fund to pay for facing upgrades, locks and any other incidental expenses for the cabinets behind the chancel
    - Dana voted to approve; Tom seconded; all in favor
  - Charley Earp looking to do second year of internship with us
    - Wants to get experience with worship/pastoral care
    - Probably not paid part of course work
    - 20 hours per week; mid-August 2017 thru mid-June 2018
    - Advantages: New energy brought in can be helpful for the congregation, pastoral care support
    - Disadvantages: Time commitment for Adam and time away from the church
    - Project in their second year infrastructure project
    - Dan what are some ways that we could prepare ourselves to be a welcoming place for interns in the future?
    - Adam to get back to him and let him know we are not able to host him in the coming year
  - World Music Concert Series for 2017-18 to organize performances looking to kick-off in May 2017
  - Making Peace with Religious Past and World Religions Tom suggested posting info on outdoor signage
  - Signage we know of at least one person in the sanctuary who came in because of the sign
- Congregational Administrator's Report
  - voting Location Worth the Hassle?
    - A lot of time, energy, expense
    - What does it do for us?
    - Dan fundamental for democracy
    - Susan R helps people to know us, makes uncomfortable that they damage our property, important civic
    - Mary-Helen with Dan and Susan R
    - Andrew sees merit in supporting democracy, and supporting public service; people largely seem to be here just to vote; time is taxing – how supposed to spend time versus actual time spent; are we able to support democracy in other ways?
    - Adam if we are not a polling place, we should make sure we do other things to be engaged in democratic process – ex – candidate forum, more voter registration, etc.




