

LEGISLATION

November 2018 Qualified Statewide Ballot Measures Initiatives and Referenda Cleared for Circulation

The Attorney General prepares a circulating title and summary of the chief purpose and points of a proposed initiative measure. Proposed initiative measures are cleared for circulation on the day the circulating title and summary is sent to the initiative proponents.

Proposition 1. SB 3 (Chapter 365, Statutes of 2017), Beall. Veterans and Affordable Housing Bond Act of 2018.

Requires That Proceeds of Bonds or Taxes Approved by the Voters Be Spent on the Specific Projects or Uses Approved by the Voters. Initiative Constitutional Amendment.

Prohibits state and local governments and special districts from spending proceeds of bonds or taxes approved by the voters for any purpose other than those provided in the measure authorizing those bonds or taxes. **Summary of estimate by**

Legislative Analyst and Director of Finance of fiscal impact on state and local government:

Potentially less state and local fiscal flexibility over the use of bond proceeds and tax revenue, depending upon future decisions made by elected officials, the courts, and the voters.

Proposition 2. No Place Like Home Act of 2018.

Among other provisions, this will authorize the Legislature to appropriate for transfer money's in the Mental Health Services Fund to the Supportive Housing Program Subaccount.

Proposition 3. Authorizes Bonds to Fund Projects for Water Supply and Quality, Watershed, Fish, Wildlife, Water Conveyance, and Groundwater Sustainability and Storage. Initiative Statute.

Authorizes \$8.877 billion in state general obligation bonds for various infrastructure projects: \$3.03 billion for safe drinking water and water quality, \$2.895 billion for watershed and fisheries improvements, \$940 million for habitat protection, \$855 million for improved water conveyance, \$685 million for groundwater sustainability/storage, and \$472 million for surface water storage/dam repairs. Appropriates money from General Fund to pay of

bonds. Requires certain projects to provide matching funds from non-state sources; gives priority to disadvantaged communities.

Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government:

State costs of \$17.3 billion to pay off principal (\$8.9 billion) and interest (\$8.4 billion) on bonds over a 40-year period. Annual payments would average \$433 million. Annual payments would be lower than this average in the initial and final few years, and somewhat higher in the intervening years. Varying fiscal effects on individual local governments depending on specific projects undertaken, amount of grants and loans received, and amount of local cost-share required.

Proposition 4. Authorizes Bonds Funding Construction at Hospitals Providing Children's Health Care. Initiative Statute.

Authorizes \$1.5 billion in bonds, to be repaid from state's General Fund, to fund grants for construction, expansion, renovation, and equipping of qualifying children's hospitals. Designates 72 percent of funds to qualifying private nonprofit hospitals providing comprehensive services to high volumes of children eligible for governmental programs and children with special health needs eligible for the California Children's Services program, 18 percent of funds to University of California general acute care children's hospitals, and 10 percent of funds to public and private nonprofit hospitals providing services to children eligible for the California Children's Services program. **Summary of**

estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local

government: State costs of \$2.9 billion to pay off principal (\$1.5 billion) and interest (\$1.4 billion) on bonds over a 35-year period. Annual payments would average \$84 million. Annual payments would be lower than this average in the initial and final few years, and somewhat higher in the intervening years.

Proposition 5. Changes Requirements for Certain Property Owners to Transfer Their Property Tax Base to Replacement Property. Initiative

Constitutional Amendment and Statute.

Removes the following current requirements for homeowners who are over 55 years old or severely disabled to transfer their property tax base to a replacement residence: that replacement property be of equal or lesser value, replacement residence be in a specific county, and the transfer occur only once. Removes similar replacement-value and location requirement on transfer for contaminated or disaster-destroyed property. Requires adjustments to the replacement property's tax base, based on the new property's value. **Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government:** Annual property tax losses for cities, counties, and special districts of around \$150 billion in the near term, growing over time to \$1 billion or more per year (in today's dollars). Annual property tax losses for schools of around \$150 million per year in the near term, growing over time to \$1 billion or more per year (in today's dollars). Increase in state costs for schools of an equivalent amount in most years.

Proposition 6. ("Gas Tax") Eliminates Recently Enacted Road Repair and Transportation Funding by Repealing Revenues Dedicated for those Purposes. Requires any Measure to Enact Certain Vehicle Fuel Taxes and Vehicle Fees be Submitted to and Approved by the Electorate, Initiative Constitutional Amendment. Repeals a 2017 transportation law's tax and fee provisions that pay for repairs and improvements to local roads, state highways, and public transportation. Requires the Legislature to submit any measure enacting specified taxes or fees on gas or diesel fuel, or on the privilege to operate a vehicle on public highways, to the electorate for approval. **Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government:** Reduced annual state transportation tax revenues of \$2.9 billion in 2018-19, increasing to \$4.9 billion annually by 2020-21. These revenues would primarily have supported state highway maintenance and rehabilitation, local streets and roads, and mass transit. In addition, potentially lower transportation tax revenues in the future from requiring voter approval of such tax increases, with the impact dependent on future actions by the Legislature and voters.

Proposition 7. Permanent Daylight Savings Time Measure. Proposition 7 would allow the California

State Legislature to establish permanent, year-round daylight savings time (DST) by a two-thirds vote if the federal Uniform Time Act is changed to allow for permanent DST. As of 2018, the Uniform Time Act allows states to adopt one of two options: (a) adopt DST between the second Sunday of March or the first Sunday of November or (b) remain on standard time all year. In 2016, the California State Legislature asked the President and Congress to pass an act that would allow California to adopt year-round DST. In March 2018, Florida also asked the federal government to allow the state to enact year-round DST. To enact Proposition 7, Proposition 12 (1949), a ballot initiative that established DST in California, would need to be repealed. In California, a ballot initiative cannot be repealed without consent of voters. Therefore, the state legislature cannot take action unless voters approved Proposition 7.

Proposition 8. Authorizes State Regulation of Kidney Dialysis Clinics. Limits Charges for Patient Care. Initiative Statute. Limits amounts outpatient kidney dialysis clinics may charge for patient care and imposes penalties for excessive charges. Requires annual reporting to the state regarding clinic costs, patient charges, and revenue. Prohibits clinics from discriminating against patient based on the source of payment for care. **Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government:** State administrative costs of around \$1 million annually to be covered by increases in license fees on chronic dialysis clinics. State and local government savings largely associated with reduced government employee and retiree health benefits spending on dialysis treatment, potentially up to tens of millions of dollars annually.

Proposition 9. Division of California into Three States. Initiative Statute. On July 18, 2018, Proposition 9 was removed from the ballot by order of the California Supreme Court.

Proposition 10. Expands Local Governments' Authority to Enact Rent Control on Residential Property. Initiative Statute. Repeals state law that currently restricts the scope of rent-control policies that cities and other local jurisdictions may impose. Allows polices that would limit the rental rates that residential-property owners may charge for new tenants, new construction, and single-family homes. In accordance with California law, provides that

rent-control policies may not violate landlords' right to a fair financial return on their rental property. **Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government:** Unknown, but potentially significant, changes in state and local government tax revenues. Net decrease more likely than net increase. Potential increase in local government costs of up to tens of millions of dollars per year in the long term, likely paid by fees on owners of rental housing.

Proposition 11. Requires Private-Section Emergency Ambulance Employees to Remain on Call During Work Breaks. Changes Other Conditions of Employment. Initiative Statute.

Makes the labor law that entitles hourly employees to take work (meal and rest) breaks without being on call inapplicable to private-section emergency ambulance employees. Regulates timing of meal breaks for these employees. Exempts employers from potential liability for violations of existing law regarding work breaks. Requires employers to pay for employees to be trained regarding certain emergency incidents, violence prevention, and mental health and wellness. Requires employers to provide employees with certain mental-health services. **Summary of estimate by Legislative**

Analyst and Director of Finance of fiscal impact on state and local government: Local government net savings likely in the tens of millions of dollars annually due to lower emergency ambulance contract costs.

Proposition 12. Establishes New Standards for Confinement of Certain Farm Animals; Bans Sale of Certain Non-Complying Products. Initiative Statute.

Establishes new minimum space requirements for confining veal calves, breeding pigs, and egg-laying hens; requires egg-laying hens be raised in cage-free environment after December 31, 2021. Prohibits certain commercial sales of specified meat and egg products from animals confined in non-complying manner. Defines sales violations as unfair competition. Creates good faith defense for sellers relying upon written certification by suppliers that meat or animal products comply with new confinement standards. Requires State of California to issue implementing regulations.


Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government: Potential decrease in state and local tax revenues from farm businesses, likely not to exceed the low millions of dollars annually. Potential state costs ranging up to ten million annually to enforce the measure.

IN THE NEWS**FIDELITY, BRAVERY, INTEGRITY**

In 1924, J. Edgar Hoover was appointed Acting Director of the Bureau of Investigation as it was called then. The name of the organization was later changed to the Federal Bureau of Investigation. Upon his appointment as Director, J. Edgar Hoover began purging the organization of political hacks and incompetent individuals. He put in place strict rules and regulations for handling investigations and personal conduct by which all FBI personnel were expected to abide. It was J. Edgar Hoover who established the Identification Division, the Laboratory Division, and the FBI National Academy. He served 16 Attorneys General and 10 Presidents. DEATH OF A CITY'S SIDEWALKS: THE CRACK-UP

One of the first things a visitor to Los Angeles notices is the odd way the sidewalks are lifting up and running downhill. There's a simple explanation. The sidewalks are trying to escape. You can't blame them. Not only have they

been conscripted to serve as campgrounds for tent cities, they are the floors of pop-up restaurants and flea markets, and — in a crowning indignity — they have now been turned into raceways and parking racks for flocks of motorized scooters. It's enough to make anybody crack.

Cities throughout California are grappling with the same problem. Los Angeles is providing leadership on this issue with its usual motto, "If you can't be a good example, you can always be a horrible warning." The problem began to spin out of control in 2007 when the city reached a settlement with the ACLU in a lawsuit over an ordinance that banned sleeping on the sidewalk. L.A. officials agreed not to enforce the ban at night until 1,250 new units of permanent supportive housing were constructed. That set the stage for semi-permanent tent cities on the sidewalks.

This was a tremendous inconvenience for the city's estimated 50,000 illegal street vendors. But then the vendors caught a break when Donald Trump was elected president. Panicked that the Trump administration would use arrests under the city's law against street vending as an excuse to deport people, the L.A. City Council decriminalized street vending within weeks of Inauguration Day. New regulations that will fully legalize street vending are in the works.

Under the proposed regulations, vending would be banned near tourist attractions like the Hollywood Walk of Fame, which has recently become so crowded with unlicensed vendors that the tourists are being forced to walk in the street. This interferes with the progress of bicyclists, scooter-riders and city planners who want to build pocket parks in parking spaces. So to keep the tourists on the sidewalk, the city's Bureau of Street

Services is enforcing 56.11, an ordinance that prohibits the storage of bulky items on the sidewalk. Three blocks of Hollywood Boulevard have been declared a "Bulky Item Special Enforcement Zone."

Vendors who pay rent for legal kiosks, which can run \$5,000 a month in the good locations, would like to see the unlicensed vendors and their folding tables evicted from the boulevard, but unless the illegal vendors wrote something unacceptable during a late-night tweetstorm, nothing will stop them from working in Hollywood.

Nothing can shut down the illegal restaurants, either. Giant stainless steel grills shooting flames at meat on a chain are popping up around the city, surrounded by plastic chairs and tables that may have come out of a recycle bin. L.A. County has a Street Vending Compliance Program that requires the food vendors to have potable water for hand-washing, sanitary conditions for food handling and restrooms for the food handlers, but the program has only 10 inspectors for the entire county. "It may take some time to address each complaint," the county's website advises.

There are frequently restrooms on the sidewalks, especially in San Francisco, but they lack soap, water, plumbing and walls. So be careful, if you're walking on a sidewalk in California, that when you step around the invisible restroom you don't accidentally trip on the invisible motorized scooter rack.

If you haven't seen these scooters yet, they look like the old-fashioned Dennis-the-Menace kind, two wheels attached to a narrow platform and controlled with a set of handlebars on a pole. But they're also controlled by an app. If you download it to your phone you can activate the scooters wherever you find them on the sidewalk, ride them for as long as you like and leave them on the sidewalk wherever you end up.

Culver City and Santa Monica have indulged these in pilot programs, but so far San Francisco has banned them. Los Angeles is reviewing proposed regulations. A lot of people ride these scooters on the sidewalks, which may be cost-effective in the long run, because broken pavement in the bike lanes cost L.A. taxpayers \$19 million last year in legal payouts over horrible wrecks. No wonder the sidewalks are cracking up. You can't blame them for trying to make a break for it.
