### **Please note: The Combined Proceedings will no longer be available in book or CD format beginning with the 2018 volume.**

Currently all 65 volumes of the Combined Proceedings are available online for members to access at no extra cost. Due to continuing increases in printing and distribution costs and with improved member access to the IPPS Online Proceedings Library, the International IPPS Board has decided that volume 67 (2017 conference papers) will be the last edition of the Combined Proceedings printed in the "Black Book" format and distributed in the traditional way.

Starting with the 2018 regional conference papers (Vol.68), papers will be edited in the traditional manner and then uploaded to the IPPS website. The papers will look similar to what is currently available in the printed edition, with the addition of PowerPoint presentations. All members will be able to print individual papers or the entire proceedings directly from the IPPS website. One of the main advantages of this change will be a dramatically reduced time between a regional conference and the publication of the Proceedings on the IPPS website!
