## I. OBJECTIVE AND DESCRIPTION

The Friends of The Metropolitan Black Bar Association as the charitable arm of the Metropolitan Black Bar Association (MBBA) provides financial scholarships to help prospective and current law students from diverse backgrounds. Additionally, these scholarships are part of the MBBA Pipeline and “#MBBAGIVES” programs where under these initiatives the purpose is to promote greater diversity within the profession, particularly from populations underrepresented in the field, and to help future leaders of the profession from such diverse backgrounds afford a legal education. The purpose of this scholarship is to cover the costs for preparatory courses for the Law School Admissions Test (LSAT). **This year’s scholarship theme is “Black Lawyers Matter.”**

## II. ELIGIBILITY

To be eligible to receive a scholarship, an applicant must be of a racially or ethnically diverse background, a permanent resident of New York City, and registered for an upcoming LSAT within the 2016-2017 test administration cycle (<http://www.lsac.org/jd/lsat/test-dates-deadlines>).

\*Applicants who are immediate family members of MBBA Board of Directors are ineligible to receive a scholarship.

\*\*Applicants who are currently enrolled in an LSAT Prep course will be eligible for reimbursement if selected. Proof of course payment required.

## III. SELECTION CRITERIA

In addition to the eligibility requirements above, selection criteria include:

- A. Undergraduate and graduate (if applicable) academic record
- B. Demonstrated leadership skills
- C. Relevant work experience
- D. Community service
- E. Financial need
