Session A (8:00 am - 10:00 am)

A.1 Leadership at all Levels – Betsy Saatman

Let's learn about leadership skills, how to acquire them and how to foster them at all levels within your organization. Upon completion the learner will be able to:

- * Identify leadership skills
- * Strategize the next steps to fostering leadership

A.2 Guiding Behavior of our Youngest Children (Infants & Toddlers) - Cynthia Pollach

Early stages of exploration and interactions among infants and toddlers can include behaviors such as a child grabs toys, pulls hair, hits, pushes, pokes, or bites. This class shares why young children resort to these behaviors, and how professionals can use positive guidance to help children learn to solve problems without hurting others. Assessments of current guidance practices are included to determine if improvements are needed to enhance the quality of care for infants and toddlers.

A.3 Strategies for Challenging Behavior - Deb Yambor

This course is suitable for all level of providers, and is designed to help providers identify those behaviors children exhibit in the classroom that cause behavioral and class-room community difficulties. Strategies will be provided that demonstrate best-practice socially and emotionally, utilize and enhance professional ethics, explain and role-play responsive vs. reactive teaching strategies, discussion of beliefs and identifying those issues that can trigger providers as well as taking into account safety issues and program limitations.

A.4 DAP Art for Infants and Toddlers – Kim Alloway

It is sometimes difficult for us to think of art as something other than handprints and cute projects that our infants and toddlers produce. This training challenges us to embrace the true idea of art, and helps us understand what art in the infant and toddler classroom really looks like. We will use the fundamentals of DAP and the ITERS as the guidelines that will allow us to provide meaningful and appropriate exposure to art, and the materials used to create art.

A.5 Understanding the New STARS Standards – What do They Mean for Me-a Family Provider? – Jen DeStephano

Review of new STARS standards (STAR 2 as well as STAR 3/4), what the intentions behind the standards are and how they apply to a family child care provider. Specific discussion of practical use of Individualized Professional Development Plans and how to utilize them to further professional development. Various ways to document each standard will be discussed, focusing on providers reflecting to see how they may already be meeting many of the standards.

A.6 DAP Observation: Using Your Observation to Support Intentional Teaching – Rose Snyder

In this session participants will identify key components of DAP that will support intentional teaching. Participants will examine the components of observation, developmentally appropriate practice and compare tools/strategies that support ongoing collection and use of student observation that leads to intentional teaching and positive outcomes for children. Bring a sample observation with you to this interactive session. We will discuss ways to use the information collected with families as a tool to involve families in the planning process for improved outcomes for children and improved family engagement.

A.7 Understanding the New STARS Standards – What do They Mean for Me and my Center? – Jenn Wertz

Review of new STARS standards (STAR 2 as well as STAR 3/4), as they relate to center directors and staff, as well as explanation of the intent behind each standard. Specific discussion of practical use of Individualized Professional Development Plans and how to utilize them to further professional development. Various ways to document each standard will be discussed, focusing on providers reflecting to see how they may already be meeting many of the standards.

A.8 Program Wide PBIS: Module 1 – Tyler Hoffman

Program-wide PBIS Module 1 - SPEC focuses on social emotional development in the context of relationships and environment. The content in this module has been modified from the original CSEFEL Training Modules. The content spans the development from infancy to preschool years. A variety of learning modalities will support all learning styles (ex: discussion, activities and video).

Session B (10:15 am - 12:15 pm)

B.1 Environment, Behavior, and Supervision – Betsy Saatman

Step back evaluate and adjust. Together we will explore the current environment, the behaviors and supervision, and how they work together. Upon completion we will have some reflective data that will support environmental changes and that will support differing supervision styles and behavioral changes.

B.1 Building Resilience – Cynthia Pollach

Children who experience adverse childhood experiences (ACEs) face an increased risk for social-emotional, physical and mental health issues. ACEs include abuse, neglect, poverty and other traumatic experiences encountered before the age of eighteen. This class promotes the awareness and understanding of trauma in young children and families and discusses the role of early care and education professionals in nurturing resilience in the children and families in their care who

B.3 Appreciative Inquiry: Being at my best as an Early Childhood Education Professional - Deb Yambor

This course is designed to help engage professionals from the perspective of positive regard for their field, ECE. It is designed to ask and allow participants to reflect upon valuable perspectives of working in the field of ECE. As the 3 hour session unfolds, each person in attendance is given time to explore when they were at their best working with children, what values and behaviors led them to have such a positive experience, and how to enhance those traits to continue growing as professionals in the field of ECE.

B.4 DAP Art for Infants and Toddlers – Kim Alloway

It is sometimes difficult for us to think of art as something other than handprints and cute projects that our infants and toddlers produce. This training challenges us to embrace the true idea of art, and helps us understand what art in the infant and toddler classroom really looks like. We will use the fundamentals of DAP and the ITERS as the guidelines that will allow us to provide meaningful and appropriate exposure to art, and the materials used to create art.

B.5 Ages and Stages – Lindsey Gristick

Participants will learn how to use the ASQ® and ASQ:SE® as a screening tool for children ages 3 months to 5 years. The session provides information on how to administer and score the screener and share results of the screener with families. Including resources for making referrals to additional services if needed.

B.6 Let's Talk-Understanding Cultural Competence – Rose Snyder

In this course participants will have the opportunity to examine the definition of CULTURAL COMPETENCE as established by a team of ECE professionals from across the state. Participants will discuss the meaning of cultural competence and the journey to understanding others. This session is an interactive discussion about attitudes and personal reflections designed to help participants grasp the meaning of cultural competence and their role in creating an environment where all people are valued and respected for who they are and what they bring to the community.

B.7 STARS Orientation Part 1 – Carrie Kitchen

Overview of STARS System and CQI (Continuous Quality Improvement) Principles. Learn more about the history & purpose of STARS, resources available to you as a STARS provider, and how we can help you continue to reach for higher quality levels.

B.8 Program-wide PBIS Module 2 - Tyler Hoffman

Program-wide PBIS Module 2 - SPEC focuses on tier 2 targeted supports through promoting social emotional competence and intentional teaching. The content in this module has been modified from the original CSEFEL Training Modules. The content spans the development from infancy to preschool years. A variety of learning modalities will support all learning styles (ex: discussion, activities and video).


