JUDGING CRITERIA & WHAT TO WEAR

JUDGES INTERVIEW

The judge's personal interview is an opportunity for the contestant to represent themselves as an individual and show their personality. Each contestant will have interview in round robin format with 3 minutes with each judge. This will be a pleasant and enjoyable atmosphere where the judges will get to know you better. Interview counts for **25%** of the contestant's overall score.

ON STAGE COMPETITION

Casual Wear (Little Miss & Preteen ONLY)

Each contestant will wear the following attire during this segment:

- White sneakers ("white" must be the dominant color, but the sneaker can have a stripe or splash of another color)
 - White socks NOT ABOVE THE KNEE
- White shorts NOT BELOW THE KNEE with a belt of your choice
 - T-shirt provided by the Little Miss United States

The Casual Wear competition counts for **25%** of the contestant's overall score.

Swimsuit & Fitness (Jr Teen-Mrs ONLY)

In the Swimsuit phase of competition, contestants are required to walk across the stage in a swimsuit and high-heeled (nude or silver or clear only). In recent years, two-piece swimsuits have become a popular choice among contestants but one-piece swimsuits are also allowed. Per policy of this organization, thongs, string bikinis, and/or Brazilian bikinis are not allowed. All swimwear must be appropriate for a family environment. The Swimsuit competition counts for **25%** of the contestant's overall score.

Evening Wear

In the Evening Wear phase of competition, contestants are required to walk across the stage in an evening gown of their choice (full length). Judges will score based on poise and grace of each contestant.

The Evening Wear portion of the competition counts for **25%** of the contestant's overall score.

Onstage Question

During this phase, contestants are asked a random question from a predetermined list that they must then answer onstage with no preparation. Questions normally allow the contestant to talk about herself or give her opinion of general issues. Current events are not normally discussed during this phase of competition in the Miss United States system. The Onstage Question counts for **25%** of the contestant's total score. (NOTE: The questions will not be of political nature and will be age driven for each division.)

Congeniality

The delegates will each vote on who they believe shows the true meaning of Miss United States Organization with kindness, helpfulness, and friendliness.

Photogenic * Evening Gown * Casual Wear/Fitness

A winner will be selected by the highest score in each age division. Photogenic is based on the submitted program book picture.

Miss Georgia United States Official Rules and Conditions

Little Miss Georgia United States

- Is between the ages of 8 to 9 years old as of January 1st 2018
- Is single, not married, or never been married
- has never posed nude in print, media or film
- Is a natural born female who is not pregnant or has never given birth
- Is a resident, attends school, or is a military family in Georgia

PreTeen Georgia United States

- Is between the ages of 10 to 12 years old as of January 1st 2018
- Is single, not married, or never been married
- has never posed nude in print, media or film
- Is a natural born female who is not pregnant or has never given birth
- Is a resident, attends school, or is a military family in Georgia

Jr Teen Georgia United States

- Is between the ages of 13 to 15 years old as of January 1st 2018
- Is single, not married, or never been married
- has never posed nude in print, media or film
- Is a natural born female who is not pregnant or has never given birth
- Is a resident, attends school, or is a military family in Georgia
- Is a US Citizen by proof of birth certificate

Teen Georgia United States

- Is between the ages of 16 to 19 years old as of January 1st 2018
- Is single, not married, or never been married
- has never posed nude in print, media or film
- Is a natural born female who is not pregnant or has never given birth
- Is a resident, attends school, or is a military family in Georgia
- Is a US Citizen by proof of birth certificate

Miss Georgia United States

- Is between the ages of 20 to 29 years old as of January 1st 2018
- Is single, not married, or never been married
- has never posed nude in print, media or film
- Is a natural born female who is not pregnant or has never given birth
- Is a resident, attends school, or is a military family in Georgia
- Is a US Citizen by proof of birth certificate

Ms. Georgia United States

- Is between the ages of 20 to 29 years old as of January 1st 2018
- Must have been previously married, or had a child, or both but be currently unmarried
- has never posed nude in print, media or film
- Is a resident, attends school, or is a military family in Georgia
- Is a US Citizen by proof of birth certificate

Ms. Georgia Woman United States

- Must be 30 years old or older as of January 1st 2018
- Must have been previously married, or had a child, or both but be currently unmarried
- has never posed nude in print, media or film
- Is a resident, attends school, or is a military family in Georgia
- Is a US Citizen by proof of birth certificate

Mrs. Georgia United States

- Mrs. contestant understands and agrees that she must be married at least 6 months to her spouse.
- Entrant must not have posed for provocative photos or in nude print.
- Entrant must be a U.S. Citizen.
- Is a resident, attends school, or is a military family in Georgia
- Is a US Citizen by proof of birth certificate

All Entrants:

- Agree that the decisions of the judges are final.
- Agree to attend and compete in this year's United States National Pageant if selected the winner, and further agrees to abide by all the required services, rules and regulations governing this pageant.
- The term entrant is defined as a naturally born female meeting the criteria outlined in the rules and regulations.
- Entrant understands that the fee to appear on the National stage has been paid for part of the winners' prize package.
- Entrant understands if chosen *Mrs. Georgia United States* there will be some additional expense to compete in the National pageant. This will be the responsibility of the newly crowned winner.
- If the Mrs. winner chooses to room with another state at the national pageant your room is paid for.
