## NEW CALIFORNIA LAW PROTECTS PATIENTS FROM SURPRISE MEDICAL BILLS

Effective July 1, Californians received new protections from surprise medical bills issued by medical providers and insurance companies. The protections focus on those patients who are forced to go to “out-of-network” providers to get the treatment they need.

Under the new state law, a patient who visits an in-network facility, like a hospital, lab or radiology office, you are responsible only for the in-network costs—even if you are forced to go to an out-of-network facility or provider.

According to the San Jose Mercury News, “a 2015 Consumers Union survey found that nearly 1 in 4 Californians who visited a hospital or had a surgery in the previous two years were charged an out-of-network rate when they thought a provider was in-network.”

An example cited by the Mercury News was when a patient schedules a surgery at an in-network facility, with an in-network surgeon, but the anesthesiologist is out-of-network. The patient would then get a surprise bill for the anesthesiologist at the out-of-network rate. The new law is designed to protect patients in those instances.

The new law protects those in the private insurance markets. Some of our members are now moving to those types of coverages because of the City’s move to high-cost deductible plans until they qualify for Medicare.

Just because there’s a new law, don’t expect providers to start complying right away.

To protect yourself, it is recommended that you read any bill you receive carefully. If its an out-of-network bill provide it to your insurance and file a grievance if necessary. If the insurance company does not resolve the issue for you, the Department of Managed Health Care can be contacted at [www.health-help.ca.gov](http://www.health-help.ca.gov) or 888-466-2219.

The law does allow out-of-network providers to bill out-of-network rates if you voluntarily sign a form 24 hours before you receive care. You don’t have to sign it unless you want to receive out-of-network services at out-of-network rates.
