



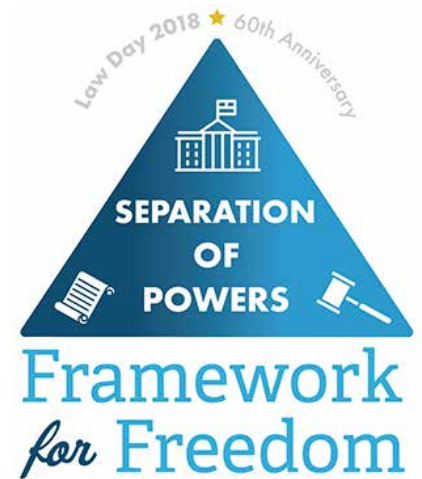

President's Comments

The first nationwide commemoration of Law Day was May 1, 1958. President Dwight D. Eisenhower established it as a “day of national dedication to the principles of government under law.”

This year the American Bar Association has designated Law Day’s theme as “Separation of Powers: Framework for Freedom.” The United States Constitution vests legislative, executive, and judicial power in Congress, a President, and the Supreme Court, respectively. These three separate branches of the national

government share power and serve as checks on each other. While separation of powers provides a framework for freedom, this framework is not self-executing. We the people must continually ensure that our constitutional democracy endures, preserving our liberties and guaranteeing our rights. And that includes preserving the independence of our courts.

Lack of judicial funding at the state level threatens judicial independence. State court systems have been chronically underfunded for over a decade. The American Bar Association’s Task Force on the Preservation of the Justice System labeled it “one of the most critical issues facing the legal profession.” States, including Alabama, are not sufficiently funding the courts. As a result, operating funds are generated by fines on criminals and fees to litigants. Further, as I discussed in my January 2018 comments, in Alabama, court funds are siphoned off to bolster the General Fund and serve non-judicial needs.

In 2018, after a full court press from judicial advocates around Alabama, trial court funding was increased by \$2.49 million in the 2018-2019 budget. While that is a move in the right direction, it is a drop in the bucket for a system that has experienced reduced appropriations from the Alabama General Fund from \$163 million in 2010 to \$95 million in 2018. Moreover, as of the time of this writing, none of that additional funding is earmarked for Mobile County's Thirteenth Judicial Circuit where the ratio of cases to judges is higher than the state average and higher than similar large metropolitan areas. Courts should be focused on administering fair and impartial justice, not on funding government. Judicial independence is the cornerstone of our democracy, and forcing the judiciary to be a revenue generator endangers both that independence and public confidence in our system.



SIGNIFICANT DECISIONS

Following the **ALABAMA SUPREME COURT'S** earlier decision in *Reese v. Robinson*, 523 So. 2d 398 (Ala. 1988), the Court of Civil Appeals in **RIOPROP HOLDINGS, LLC V. COMPASS BANK**, No. 2160673 (Ala. Civ. App., January 12, 2018), held that the three-year statute of limitations within which a tax sale purchaser not otherwise in possession of the property must initiate an ejectment action to obtain possession of the property began to run the day after the purchaser became entitled to a tax deed. The purchaser's action was thus late and the original owner was determined to be the rightful owner.

In a decision on certiorari clarifying the standard under which a trial court can modify an award of alimony, the Supreme Court in *EX PARTE WILSON*, No. 1160101 (Ala., January 16, 2018), reversed the Court of Civil Appeals and the trial court and held that a party could obtain a modification of a prior alimony award by showing changed circumstances that had arisen since the last order awarding or modifying alimony, rather than since the last judgment of the court addressing the issue. Thus, an intervening action to modify, which had been denied based on the husband's failure to comply with discovery, was not the measuring point for determining the relevant time after which the changed circumstances must be shown.

In *BALLARD V. LEE A. MCWILLIAMS CONSTRUCTION, INC.*, No. 2160469 (Ala. Civ. App., February 2, 2018), the Court of Civil Appeals held that (a) it was precluded from considering whether the non-jury judgment from which an appeal was taken was supported by the evidence because the appellant had failed to file a post-judgment motion raising that issue, and that (2) prejudgment interest was due on a judgment even though the parties disagreed on the amount and even though certain adjustments were made in the amount during the course of discovery.

In *SPENCER V. SPENCER*, No. 1161095 (Ala., February 16, 2018), the Supreme Court affirmed a Mobile County Probate Court order admitting a lost will to probate and summarized the evidence that the trial court and appellate court found to be sufficient to overcome the presumption that the unavailability of the original will meant that it had been revoked.

In reaffirming a traditional tort-law concept, the Supreme Court in *DEKALB-CHEROKEE COUNTIES GAS DISTRICT V. RAUGHTON*, No. 1160838 (Ala., February 23, 2018), held that the tort of negligence could not be established as a matter of law because the accident could not have been reasonably foreseen by the defendant.

In *WARREN V. WARREN*, No. 2161054 (Ala. Civ. App., February 23, 2018), the Court of Civil Appeals affirmed an ore tenus trial court ruling because no transcript was ordered as part of the appeal and no summary statement of the facts as permitted under Rule 10 of the Alabama Rules of Appellate Procedure was presented. Accordingly, the Court was required to presume that the evidence supported the trial court's decision.

Upon his return to Mobile, Tom started the law firm of **COLLINS, GALLOWAY, AND MURPHY**, where he practiced for over 50 years. He was a member of many professional organizations, the American Legion, the Friendly Sons of St. Patrick and St. Ignatius Catholic Church. Tom is survived by his wife, 3 sons, two of whom (**TOM GALLOWAY, JR.** and **ROBERT GALLOWAY**) are members of the MBA, 9 grandchildren, and 4 great grandchildren.
