



Butterfield retired from the judiciary after 15 years of service and successfully ran for Congress. He was elected to serve the First District of North Carolina in the U.S. House of Representatives in a special election on July 20, 2004, where he continues to serve today. Butterfield serves in the Democratic leadership as Chief Deputy Whip and is the immediate past Chair of the Congressional Black Caucus. He sits on the influential Committee on Energy & Commerce as the 4th most senior Democrat on the Health Subcommittee. In addition, he serves as a member of the Subcommittees of Communications and Technology and Energy.

When Jim Clyburn came to Congress in 1993, he was elected co-president of his freshman class and quickly rose through leadership ranks. He was elected Chairman of the Congressional Black Caucus in 1998 and Vice Chair of the House Democratic Caucus in 2002. Three years later he was unanimously elected Chair of the House Democratic Caucus, and when Democrats regained the House majority in 2006, Congressman Clyburn was elevated by his colleagues to House Majority Whip. As a national leader he has championed rural and economic development. Many of his initiatives have become law.

Specifically, she was an advocate for Lifeline Modernization, which assists low income consumers defray the cost of broadband service, championed diversity in media ownership, initiated Inmate Calling Services reforms, emphasized diversity and inclusion in STEM opportunities, and fought to preserve a free and open internet. Prior to the FCC, she spent 11 years as a member of the sixth district on the Public Service Commission (PSC) of South Carolina. Prior to the PSC, Clyburn was the publisher and general manager of her family-founded newspaper for 14 years, the Coastal Times, a Charleston-based weekly newspaper that focused primarily on issues affecting the African American community.

In 1998, Congresswoman Barbara Lee was elected to serve California's 9th congressional district (now the 13th) in a special election. In 2001, Congresswoman Lee received national attention as the only Member of Congress to oppose the authorization for the use of military force (AUMF) in the wake of the horrific events on September 11th. The Congresswoman believed this AUMF would become a blank check for endless war. As of 2013, this authorization had been used more than 30 times to engage in military action without Congressional oversight. Congresswoman Lee is working to repeal this blank check and restore Congress's constitutional oversight to matters of war and peace. She was also an outspoken opponent of the Iraq War. Currently, Congresswoman Lee serves on the Budget Committee and the powerful Appropriations Committee, which oversees all federal government spending. She serves on three subcommittees (State and Foreign Operations; Labor, Health and Human Services, Education; and Military Construction and Veterans Affairs) of the Appropriations Committee. She currently serves as Co-Chair of the Pro-Choice Caucus. She is the former chair of the Congressional Black Caucus (111th Congress) and co-chair of the Congressional Progressive Caucus (109th & 110th Congresses).

Spencer Overton is the President of the Joint Center for Political and Economic Studies, and has led the Joint Center since February 2014. Overton is a tenured Professor of Law at George Washington University. He is also a Senior Fellow at Demos, a member of the President's Advisory Commission on Educational Excellence for African-Americans, and the national chair of public policy for the nation's oldest African-American fraternity, Sigma Pi Phi (the Boule). Professor Overton's academic articles on election law have appeared in several leading law journals, and his book *Stealing Democracy: The New Politics of Voter Suppression* was published and released by W.W. Norton. During Professor Overton's time in the Obama campaign, transition, and Administration (2007-2010), he was a key leader on the Administration's policy efforts. From 2007-2008, he was chair of Government Reform Policy for the Obama presidential campaign, a group of over 150 expert advisers from around the nation. 
