## **MINUTES OF Stated Meeting of Presbytery Assembly**

Hosted by First Presbyterian Church, Elkhart, IN Tuesday, November 15, 2016, 10 am EST

**Moderator David Smook** (TE, Honorably Retired) called the Assembly to order with the greeting, "This is the day that the Lord has made!" and prayer at 10 a.m. Liturgy and song led by praise band was integrated throughout the day with the work of the meeting. Ruling and teaching elders and guests attending for the first time were introduced, and corresponding members were seated. Docket and consent agenda were approved without dissent:

- A.1 Docket
- A.3 Minutes and roll of September 2016 Assembly
- A.4 Report of Presbytery Council as Commission
- A.5 Report of Commission on Ministry (COM)
- A.6 Report of Commission on Preparation for Ministry (CPM)
- A.7 Report of Crown Point Team as a commission
- A.8 Report of Stated Clerk
- A.9 Report of Terms of Call for 2016
- A.10 Report of Balance of Ruling Elders and Teaching Elders

Quorum was present (Appendix A.11). Assembly considered Amendment 16-D.1 (On amending G-2.0509) and 16-D.2 (On amending D-10.0401) proposed by the 222<sup>nd</sup> General Assembly and introduced by GA Commissioner Sarah Sanderson-Doughty was disapproved by voice vote after debate. Guest candidate for ordination Grace Hammer was approved to have voice after point of order was raised by Assembly members.

Assembly turned to discussion of the presbytery-wide November study of 1 Corinthians 14:36-40 and Foundations for Presbyterian Polity F-3.0105 on mutual forbearance, noting the need to hold space for one another, to remain in community even as we see the world in differing ways – church, community or politics; "we never have enough clarity to not need God;" finding the balance between being prophetic and retaining humility. Moderator David Smook continued this theme as he preached the Word, "Building Up the Saints." David recalled the year of Assemblies that moved through healing, reconciliation, mission outreach and need for holding space for one another, closing with challenge to keep looking for the common good, to find new ideas, new possibilities to answer "What is God calling us to do and be in this time and place?" "We are responsible for who we are as a church, as presbytery...Be involved, forbear one another in giving time and energy... together as presbytery in this time and place."

After song, outgoing Council Moderator Jill Kitowski invited newly elected presbytery officers forward to the baptismal font and installed:

Presbytery Assembly Moderator Sarah Sanderson-Doughty (TE, First, Elkhart) Vice Moderator Richard Ryan (CRE, Elston) Council Moderator David Smook (TE, HR)

Jill affirmed their calling, asked the constitutional questions, charged them for the coming year as officers, and closed with prayer of blessings. The stoles of leadership were passed onto installed moderators. Assembly gave a standing ovation of thanks to Jill Kitowski for her years of leadership and collaboration.

Outgoing Synod commissioner Ann Bingaman and newly elected Synod commissioner Donna Enersen reported to the Assembly the work of the Synod including its change in relationship with Peabody Retirement Community, Inc., extension of Synod Transitional Executive Sara Dingman's contract, renewal of Synod's program for newly ordained pastors, and the leadership development committee's conversations about race, most recently reading the discussing <u>Waking Up White</u> by Debby Irving and presentation by an Indianapolis group carrying out new ideas for rejuvenating neighborhoods by building on their community assets instead of focusing on deficits. Members of First, Elkhart also spoke of the value of community reading and conversation about <u>Waking Up White</u> and a deeper understanding of the concept of white privilege and its inevitable impact.

After lunch, Moderator Sarah Sanderson-Doughty recognized the many volunteers of First, Elkhart who hosted the Assembly, and announced the appointment of commissioners charged to consult with First, Plymouth congregation as the Plymouth Team: Steve Quinlan (TE, Peru), David Lawrence (TE, West Lebanon), Michael Shurn (RE, Pulaski), Rebecca Kuiken (TE, Elkhart), and John Briggs (RE, Rochester).

Assembly also renewed commissions for three ruling elders of congregations with ministry limited to administering the Sacraments in those small congregations not otherwise able to locate a teaching elder for worship. Those commissioned were Jill Kitowski (La Porte), Carrie Munson (Deer Creek) and David Abbott (Westminster, South Bend) (Appendix C.3)

Nominating Committee recognized its nominees for leadership, and after no nominations from the floor, each was elected to a specific term of service:

- Steve Quinlan (TE, Peru), Vice Moderator of COM for 2017
- Aaron Ban (TE, Chesterton), Committee on Representation, Term of 2017
- Jeff Brown (CRE, Faith, Kokomo), Synod Commissioner, Term of 2019
- Jim Perkins (RE, Rossville), Personnel Ministry Team, Term of 2018
- Spencer Bower (RE, Bethany, Lafayette), Personnel Ministry Team, Term of 2018
- David Lawrence (TE, West Lebanon), Moderator of NMDT for 2017
- Kathy Michael (RE, Pleasant Hill, Frankfort), Stewardship Ministry Team, Term of 2017

Jan Sandos (RE, Rossville) was nominated by Council and elected as Nominating Committee Moderator for 2017.

Presbytery considered two more proposed amendments from 222<sup>nd</sup> General Assembly.

- Voters approved by division of the house (after voice vote) Amendment 16-B to amend G-3.0109 to reword "parity in committees" to be congregational members and teaching elders "in numbers as nearly equal as possible."
- Moderator Sarah Sanderson-Doughty turned over the gavel to Vice Moderator Rick Ryan and spoke against approval of Amendment 16-C Sections 1-8, recommending replacing term "teaching elder" and returning to "minister of Word and Sacrament." After debate, motion to approve amendment was defeated by show of hands.
- Report of Assembly to the Office of General Assembly is found in Appendix E.

CPM Moderator Chuck Compton introduced Grace Hammer as candidate for ordination to a call approved by COM with Flora Presbyterian Church (Appendix C.5). After preaching her sermon and being examined in depth on her Statement of Faith and in the areas of theology, church governance and worship and sacraments, the motion to approve her ordination was considered through debate and defeated in a vote of 23 yes, 26 no. Assembly approved a subsequent motion to refer her to the Commission on Preparation for Ministry for further preparation and training (and requiring her transfer of care as candidate from Presbytery of Eastern Tennessee), and in partnership with Commission on Ministry to limit her scope of temporary ministry with the Flora congregation. Through discussion, the Assembly tasked CPM and COM with establishing a plan of study and benchmarks for her to meet prior to further examination for ordination.

Outgoing moderator of Stewardship Ministry Team Alan Griffin (TE, Goshen) reviewed Council's approved budget for fiscal year 2016-17, noting Council's addition of \$45,000 from Transformation Funds to balance the budget during this transitional time (Appendix D.1); *per capita* for 2017 is \$39.76 per active member. Budget reflects reduction of past operating deficit by \$95,190 after reduction in staff and office space. Contributions from all churches of their full *per capita* allocation with current reported membership would balance the presbytery budget. He provided financial report of income and expenses for July and August 2016 (Appendix D.2). He noted that a narrative budget would be emailed to congregations along with an updated *per capita* brochure the following week.

To close the meeting, the Assembly shared the Lord's Supper at the table, sang songs and offered prayers of thanksgiving and petitions. To thank him for his service, David Smook was gifted with a print visualizing being connected on a journey, with the destination not yet clear during this time of change. Assembly was adjourned at 3 pm EST with Moderator's prayer charging the community to hold space for one another.

Next Stated Assembly: Saturday, February 25, 2017, at First Presbyterian Church, 3401 N. Valparaiso St., Valparaiso, IN, with simultaneous LiveStreaming and Go-to-Meeting options at three other locations: First Presbyterian Church, Peru; First Presbyterian Church, Elkhart; and Bethany Presbyterian Church, Lafayette. Registration opens at 8 am CST in Valpo/9 am EST in the other locations. There will be brief business meeting and plenty of opportunity to hear the Word and equip congregations through a workshop provided by Rev. Richard Blackburn of the Lombard Mennonite Peace Center on Healthy Pastor-Congregation Relations.

# MINUTES OF Called Meeting of Presbytery Assembly

Hosted by Community Presbyterian Church, Rochester, IN Tuesday, December 6, 2016, 9:30 am EST

**Call** for the Presbytery Assembly meeting was issued on November 25, 2016, by email to the roster of Presbytery of Wabash Valley (*Appendix A*). **Quorum** of more than ten ruling elders and ten teaching elders was present, along with the Moderator and the Stated Clerk (*Appendix B*).

Presbytery Assembly Moderator Sarah Sanderson-Doughty called those present to order at 9:35 am with sung **prayer**, "O Come, O Come, Immanuel." Assembly accepted the **docket** as outlined in the call for the meeting. Those present read the December Bible study passage from Romans 12:1-12, and discussed its message relating to principles of Presbyterian polity.

- Assembly received report of Commission on Preparation for Ministry concerning the receipt of Grace Hammer as a candidate under care of Presbytery of Wabash Valley and its plan for her continued preparation for ordination, and COM's report on her approved scope of ministry as a candidate preaching and teaching at Flora Presbyterian Church. She will engage in six months of additional study and stand for examination for ordination at the May 2017 Presbytery Assembly.

Moderator Sarah Sanderson-Doughty presented David Smook with a framed print in gratitude for his witness and leadership as Presbytery Assembly Moderator for 2016. She adjourned the meeting with prayer at 10:20 am.

Council approved several items by consensus:

- Docket (Appendix A)
- Corporate resolution for 2017 (Appendix A.2)
- Funding from budgeted "Council Priorities" for reimbursement of \$10 each as requested for workshop and assessment: *Understanding Yourself in a Team that Thrives.*
- Bid for *SimpliSafe Security System* with cost of \$220.45 plus monthly monitoring service and connection to Emergency Dispatch Center, to be funded through office operations budget.
- Stated Clerk's update (Appendix A.5)

Minutes of Council for October 6-7, 2016 were approved after corrections of attendance and spelling of names.

Council considered a letter from Session Clerk ((Appendix B.1) on behalf of First Presbyterian Church of Valparaiso explaining its decision not to pledge to presbytery mission after finding there is no mission committee and no mission endeavor promoted by the Presbytery, and instead will fund more fully its local and global mission projects with an increase of 10%. After discussion noting the definition of mission assumed to be "outside the four walls" of churches, history of funding Geneva Center as mission of presbytery, and scant communication about shared mission efforts that do exist through presbytery coordination, Council approved a motion:

- For Council moderator in consultation with officers to appoint a committee of Council from mission-minded community of congregations to provide leadership and focus for shared support for specific mission efforts, to propose that a team with mission focus be incorporated into future presbytery structure, and to recommend for Council discernment the mission commitment of the Presbytery and funding for specific mission proposals. One specific proposal from FCP- Valparaiso to be evaluated by the newly formed Mission Committee is shared support for the Evangelical Theological Seminary (SET) in Cuba.
- Discussion of implementation agreed that invitations to volunteers would be sent in God Calls, Jennifer would write articles about mission, an electronic letter will be sent to each congregation addressed to its mission team, and that Valparaiso (Mark Mueller), Peru (Steve Quinlan), Deer Creek (Carrie & Mike Munson) and the Mishawaka (Malawi Matters) congregations already have direction mission relationships and will be invited to participate. Jennifer & David Smook will respond to Valparaiso with letter from Council announcing its action and invitation. Newly formed mission committee will report its recommendations about committee form and process to the January meeting of Council.

Council quickly reviewed proposed amendments to Personnel Policies presented by outgoing Personnel Ministry Team moderator Sandy Carlson, noted some gaps and the need for detailed review due to changes in overtime rules, cost of recent severance packages in lieu of unemployment benefits, and changes in Board of Pensions benefits for all employees including teaching elders. Council acknowledged receiving the 2012 proposed drafts and personnel policies of other presbyteries, and voted to adopt a revised personnel policy at its March 2017 meeting. Head of staff Jennifer Lewis will work with the incoming Personnel Ministry Team in preparing recommendations to Council. Personnel committee noted that Pam Camren (RE, Mishawaka) would serve as moderator of Council's search team for Stated Clerk in 2017.

Visioning & Connecting Leader Jennifer outlined presbytery vision statement options from December meeting and recent conversations. Straw poll among Council members failed to identify a clear preference, so decision about vision statement continues into 2017.

Jennifer also reported on a conversation with Nominating Committee moderator Jan Sandos asking who notifies nominees of their election to presbytery leadership positions. Discussion by Council is to recommend that it is appropriate for the Stated Clerk to give notice of action by the

Assembly, as well as to provide resources about role, processes and responsibilities and link the outgoing and incoming moderators to provide some continuity.

Stan Wilson (TE, HR and former pastor of the LaGrange congregation) introduced his regional colleague and long time friend Ken Weaver, covenant pastor of First Presbyterian Church of LaGrange for past twelve years. Ken reviewed highlights of "The Farm Project: Memo of Understanding of Ministry" (Appendix F) and accompanying news reports and brochures for the project and the congregation, citing the community needs and the depth and breadth of community engagement with Session in discerning how to respond. After questions and enthusiastic discussion, Council voted to approve a motion in support of the proposed ministry, the session's oversight responsibility, Council acknowledgement that funding is provided by the community and not directly by the congregation, anticipating the potential separation from the LaGrange church of the ministry and its assets to a separate non-profit corporation, and presbytery approval in support of FPC – LaGrange's application with OGA to be included in the PC(USA) 501c3 blanket tax exemption (Appendix F.2).

Financial consultant Eric Herzog reviewed his report for the first four months of FY 2016-17, noting income and expense both tracking below budget estimates resulting in deficit of \$25,766, close to the projected deficit of \$22,000 (previously approved by Council to be funded by \$100,000 in transformation funds during these three transitional years). Corporation fund shows balance of \$474,116 (Appendix G).

Council's Search Team for Stated Clerk/Administrative Leader presented an action item recommending changes in position description and reducing position from .75 to .5 by removing the administrative leader duties (Appendix H). Council approved without dissent. [Implementation of revised position description will require revision of current presbytery bylaws and standing rules.] Search Team will discuss proposed salary range with incoming Stewardship Ministry Team prior to making recommendation to Council.

Geneva Center, Inc.'s president of its board of directors Jim Hubbard provided a preliminary, oral report to Council on its first year as an independent entity. He reported GCI hosted 95 events, 29 of those for Presbyterian entities. Fifteen of those were from Presbyteries. There were 98 summer campers; plans for next year's summer camp including joining with Disciples of Christ churches and invitations to UCC churches. Upon his recommendation, Council approved a motion to allow GCI as lessee of Presbytery of Wabash Valley to negotiate a contract for installation of a billboard along US Highway 31 appropriate to its identity as a religious camp, with proceeds to benefit GCI.

Other Council actions:

- Approve request of Peabody Retirement Community for one-time use of presbytery mailing list to send letter to presbytery congregations announcing update of Peabody bylaws removing reference to Presbyterian church and affirming the continuing ministry of an ordained and installed teaching elder as its chaplain.
- Committed to reading <u>Waking Up White</u> by Debby Irving, the Synod-wide choice for sharing a book about racism and responding with action in 2017. Council agreed to read prior to March meeting and to prepare for discussion about preparing a video on one of the chapters as part of a Synod-wide project.
- Approved developing new presbytery website as a priority, with funding to come from pending sale of Granger Lot 2. Council set criteria of 1) easy to update, 2) to include video as well as other media access, 3) staff to receive three competitive bids to compare quality and cost, and 4) ease of access for all users.
- Celebrated report from COM of its work to organize a trained team of Advocates for

each congregation.

• Received copies of 2017 Bible Study organized around proposed Directory for Worship.

Council adjourned with prayer at 2:50 pm EST.

# Presbytery of Wabash Valley Minutes of Council 1.10.17, Page 2 of 3

Council handled several initial items by consensus:

- Approved Minutes of Council for Dec. 6, 2016, and email votes (Appendix B)
- Received Stated Clerk's update (Appendix C) and current roster of presbytery leaders
- Received COM Report of actions as a commission and update from Nominating Committee on its nominees for election at the next Assembly meeting.

In the absence of the <u>Personnel Ministry Team</u> moderator, Jennifer Burns Lewis (Visioning & Connecting Leader) reviewed the plans for that committee's work on January 24<sup>th</sup> and invited Council members to provide suggestions for edits to the current policy and samples distributed to Council in December, and prior to receiving formal recommendations from personnel committee in March. Council discussion supported proposed changes for how personnel committee does its work, including possibility of co-leaders and its assignment of a clerk to handle documentation for the committee, as a better model to share the work and to partner with head of staff.

As presbytery leader and "VCL," Jennifer built upon previous Council discernment and led conversation toward consensus to agree upon a short <u>vision statement</u> that arises out of the presbytery mission statement of its core reason for being: *Nourished by the living waters of Jesus Christ, we awaken, enliven and enhance worshipping communities to courageously extend their branches and bear new fruit in the Spirit.* The vision statement adopted by voice vote as touchstone for this presbytery:

## Serving Christ – Enhancing congregations – Connecting communities

Council discussion turned to how to live out the mission and vision by first establishing <u>priorities</u>, then setting <u>structure</u> and <u>budget</u> to support those priorities. To begin discerning priorities, Council members named significant number of small congregations struggling without pastoral leadership; many congregations with sense of isolation from other congregations as well as lack of presbytery relationships; need to build upon assets, the strengths and hopes of congregations. Informal committee focusing on leadership development will survey congregations, asking about those strengths and assets; what holds them back; and how can Presbytery of Wabash Valley collectively specifically support congregations in addition to prayer for them. The questions are intended to inspire hope. Council looked briefly at the current allocations of responsibility for presbytery work; for March Council will receive a diagram with overlay of those questions to advance thought about priorities and structure. Council was also reminded that it has agreed to read <u>Waking Up White</u> by Debbie Irving for discussion at its March meeting, in support of Council's responsibility for its leadership to; "propose missional priorities and goals each year... Oversee and ensure the coordination... Make recommendations for communications..." (*Standing Rules Article VII*)

In the excused absence of Nominating Committee moderator Jan Sandos, Linda reported briefly about the <u>Nominating Committee</u> discussion, noting that the Stated Clerk has accepted responsibility for notifying newly elected persons of their election and to inform moderators of new people and contact information for those ready to team up with particular committees or commissions. Moderators are encouraged to invite newly elected members into their working groups as one means of orientation, even prior to formal term with voting responsibility.

<u>Search Team</u> member Sarah Sanderson-Doughty updated Council on its proposed editing of the position description for the Stated Clerk the team seeks, and changes to the Ministry Information Form and posted ads inviting applications by March 3, 2017. Council **approved** by consensus a motion to set the position at half time with minimum salary of \$30,000/year plus Board of Pensions benefits and affirmed that Pam Camren (RE, Mishawaka) will moderate

<u>Financial Consultant</u> Eric Herzog reviewed preliminary financial report through October 2016, noting that SMT has not reviewed it (*Appendix G*). Operating and mission income and expenses are generally tracking the adopted budget. Council discussion focused on how to

communicate better with congregation members to demonstrate what benefits *per capita* contributions provide for their own congregation as well as the collective churches of presbytery, synod and PC(USA), in order to move past Wabash Valley's current collection rate of 67% or so of *per capita* shared based upon statistics of active members of 80 congregations. Jennifer volunteered to follow up on comments and concerns that come to presbytery about *per capita*, and to work with other on a one-page sheet that illustrates where per capita dollars go; discussion without action that this sheet be mailed to clerk of each congregation in presbytery.

Following prayers and lunch, Council approved appointment of its Mission Committee to date: Mark Mueller (TE, Valparaiso), Steve Quinlan (TE, Peru), Scott Coulter (TE, HR) and Elizabeth Monroe (RE, Valparaiso), with staff support from Jennifer. Others are invited from the NE and SW regions. Council approved plan for the committee to meet, organize its leadership and process, and recommend to Council its place in presbytery structure and priorities among mission proposals.

Vicki Dreibelbis, administrative assistance for presbytery, updated Council on steps toward a revised website. She is in the midst of pricing, platforms, content options, and requests a consultant to assist in specifying a proposal for website vendors to bid. The staff hopes to work with a consultant in order to have a detailed proposal ready for Council consideration in March.

CPM moderator Chuck Compton distributed a written plan of preparation for candidate Grace Hammer, revised to simplify channels of communication and scope of her work. Council members voiced appreciation for the extra efforts of CPM, the preparation team and Grace. *(Appendix J).* 

Council considered initial planning by officers for presbytery's first time combination of a LiveStreamed workshop and stated Assembly meeting in February from Valpo to host churches in Peru, Lafayette and Elkhart, with accommodations necessary to hold a short Assembly meeting. The approved plan includes:

- All action items will be included in an Omnibus Motion for consensus approval; any items
  pulled from that motion for discussion would be docketed for a called meeting, tentatively
  scheduled sometime in March.
- Simultaneous (two way) communication will be handled through a brief Go-to-Meeting session, with a moderator and a clerk at each site to record attendance and votes on official business.
- Deadline for registration for the Assembly lunch and to receive workshop materials is February 15<sup>th</sup>. Late registrants are welcome to attend, but host sites will not plan to prepare lunches for more than registrations nor will presbytery order extra materials at \$18 each from Lombard for the workshop. Council approved payment of all workshop materials for attendees.
- There will be no additional charge for the workshop or materials; attendees are only asked to pay \$10 for lunch and snacks to be provided by and reimbursed to the host sites.
- Teams from congregations in neighboring presbyteries will be invited to attend, honoring the grant from Synod of Lincoln Trails in support of last summer's small churches workshop and this workshop postponed from last fall.
- Council will review financial report for July 1, 2016, to December 31 2016, by email after Stewardship Ministry Team reviews them when it meets with its new members on January 17<sup>th</sup> prior to distributing to the February Assembly.

Moderator David Smook adjourned the Assembly with prayer at 1:35 pm EST.

Two rubrics: "Fear not!" and "Keep in touch!"
- COM consensus is to spend morning portion of its meetings on training led by Jennifer, continuing to work through the COM Handbook and developing revisions as needed. Consensus was to read the section on the array of pastoral relationships for training at February COM meeting.
- Received quarterly actions and reflections report of Transitional Pastor Lyle Ewing about his work with First, Monticello and preparation for electing a PNC.
- Received Stated Clerk's report and note of polity questions received.
- COM cited again the need for major revisions to presbytery website to improve access to resources for congregations and presbytery volunteers.

Discussion focused on the inclusive language of worship "together," "all baptized," "all the people." Stan Kessler (TE, HR) closed the discussion with prayer. COM members also present included Roger Hartzler (CRE, Kouts), Steve Quinlan (Vice Moderator, TE, Peru), Louis Sandos (TE, HR), Guy Wahlman (RE, Christ, Winfield), David Lawrence (TE, W. Lebanon), Sarah Bishop, (TE, South Bend First), Ann Williams (TE, HR), and Adi Veenendaal (RE, La Porte), with staff support from Linda Long (RE, Valpo and Stated Clerk) and Jennifer Lewis Burns (TE, Visioning & Connecting Leader). Jennifer reviewed the January training on being an Advocate for congregations (no longer called "TCC"), and led COM members for an hour through the section of the COM Manual on options for pastoral relationships, all with three dimensions: the pastor, the congregation and/or its session, and the presbytery through its COM. Pastors may be installed or temporary, and COM reviewed possible configurations of pastoral relationships including commissioned ruling elders, ministers of other denominations, immigrant ministers, validated specialized ministry and other contexts. To enhance congregations during times of change, COM may focus on four key areas: congregation's purpose, its passion, its possibilities, and its partners. Among the 80 congregations of Wabash Valley, 26 have vacancies, 26 are able to support full time ministry, and 54, part-time pastoral leadership.

A feeling of trust seemed to grow as the AC deeply, prayerfully listened and all openly shared.

We learned that they are maintaining good stewardship of the building and the church grounds, and have a positive intent to discern God's will.

The Team requested the members present to contact the remaining members in order to let them know (1) of the presbytery team meeting with them in order to try to prayerfully listen to God about whether the church stays open or if it is time to close; and (2) for them to contact all members in order to set a date/time for all members to have a direct consultation with the Team about this question.

Live links are provided that will take you to the General Assembly committee that handled the proposed amendment. From the list of committee business, click on the specific item number you wish to review.

Presbytery stated clerks are to report their votes to the Office of the General Assembly no later than June 25, 2017. However, in order to make changes and publish the 2017–18 *Book of Order* in a timely manner, receipt of votes prior to this deadline would be appreciated.

## Analysis by Association of Stated Clerks

## **16-A Child and Youth Protection Policy**

### On Amending G-3.0106 (Item 05-09)

#### **Brief Description**

This amendment originated as a recommendation from the Advocacy Committee for Women's Concerns. If approved, it will require all councils to adopt and implement a child and youth protection policy.

#### Assembly Action

The Assembly Committee on Mid Councils (05) amended and approved Item 05-09 with comment by a vote of 41/0. The  $222^{nd}$  General Assembly (2016) then approved a motion to reinsert [sexual misconduct policy and a] in the fourth paragraph of G-3.0106 and then approved Item 05-09 with amendment by a voice vote.

#### Arguments Supporting an Affirmative Vote

• Needed to prevent sexual harassment and for protection of children and youth

#### Arguments Supporting a Negative Vote

- There was concern over adding another policy to the Constitution
- Belief it should occur as a policy requirement outside the Book of Order
- May not be necessary for some smaller churches

## Amendment 16-E. Certified Service Requirements On Amending G-2.1101 (Item 06-15)

## **Brief Description**

The proposed amendment originated from the Committee on the Office of General Assembly. It would delete the language in G-2.1101 which refers to a "handbook."

## Assembly Action

The Assembly Committee on Church Polity and Ordered Ministry (06) voted to approve Item 06-15 by a vote of 59/0. The 222nd General Assembly (2016) approved the committee's recommendation by consensus.

## Arguments in Support of an Affirmative Vote

Many of the relevant certifying bodies do not have handbooks and should not be required to have them "Handbook" is an antiquated term

## Amendment 16-F. The Ministry of Members On Amending G-1.0304 (Item 09-11)

## **Brief Description**

This amendment proposes to add the phrase "caring for God's creation" to G-1.0304. This change is intended to show the importance of earth care issues and action.

## **Assembly Action**

The Assembly Committee on Immigration and Environmental Issues (09) voted to approve Item 09-11 by a vote of 43/11. The 222nd General Assembly (2016) approved the committee's recommendation by a vote of 429/120.

#### 16-A. Child and Youth Protection Policy On Amending G-3.0106 (Item 05-09)

The 222nd General Assembly (2016) directed the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

# Shall the fourth paragraph of G-3.0106 of the Form of Government be amended as follows? [Text to be inserted is shown as italic.]

"All councils shall adopt and implement a sexual misconduct policy and a child *and youth* protection policy."

#### **Background and Rationale**

This proposed amendment originated as a recommendation from the Advocacy Committee for Women's Concerns as Item 05-09. The Advocacy Committee for Women's Concerns provided the following rationale:

Since the child protection policy amendment went into effect after the 221st General Assembly (2014), issues have arisen regarding the interpretation of the text. Some councils have interpreted the amendment to mean that the sexual misconduct policy and child protection policy are one policy with one intent and purpose. However, the intent of the original amendment, when further reading the rationale, is that these would be two separate policies with two separate purposes.

The Advocacy Committee for Women's Concerns is also requesting we expand the language of this amendment to include "youth" as well as "child" so as to clarify the intended scope of the policy.

#### In approving Item 05-09, the General Assembly also approved the following comment:

The General Assembly notes that two separate policies are intended by this sentence, with different intents. The child and youth protection policy is intended to address interactions involving children and youth within the church or in church-sponsored activities. The sexual misconduct policy is directed toward proactively preventing and responding to sexual misconduct involving all people of all ages within the church and in church-sponsored activities.

#### Advice from the Advisory Committee on the Constitution

The Advisory Committee on the Constitution advised the 222nd General Assembly (2016) that Item 05-09 presented the following issue that the General Assembly should consider:

The Advisory Committee on the Constitution recognizes the importance of the purposes of the policies listed or proposed for G-3.0106. The ACC directs the attention of the General Assembly to its advice on Item 05-05 regarding the practice of listing required policies in the Constitution; and thus moving its function from a constitutional document towards a manual of operations.

The Advisory Committee on the Constitution also advised amending Item 05-09 by inserting "*and youth*" after "child" in G-3.0106 and commenting on the reason for two separate policies.

The Assembly Committee on Mid Councils (05) amended and approved Item 05-09 with comment 41/0. The 222nd General Assembly (2016) then approved a motion to reinsert [sexual misconduct policy and a] in the fourth paragraph of G-3.0106 and then approved Item 05-09 with amendment by voice vote.

#### **16-E.** Certified Service Requirements On Amending G-2.1101 (Item 06-15)

The 222nd General Assembly (2016) directed the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

Shall G-2.1101 be amended as follows: [Text to be deleted is shown with a strike-through; text to be added or inserted is shown as italic.]

"Persons may be certified and called to service within congregations, councils, and church-related entities, serving in staff positions. These individuals endeavor to reflect their faith through their work and to strengthen the church through their dedication. They should be encouraged by their session and presbytery to meet, or be prepared to meet, the certification requirements in a handbook provided by of a national certifying body approved by the General Assembly. Names of those who have earned certification through a national certifying body shall be transmitted to the appropriate body of the General Assembly, which will forward them to the stated clerk of the presbyteries in which those persons labor."

#### **Background and Rationale**

This proposed amendment originated as an overture from the Committee on the Office of the General Assembly (COGA) as Item 06-15. COGA offered the following rationale:

Current language in the *Book of Order* calling for a "handbook" seems antiquated and limiting. Most organizations maintain certification requirements on-line or in other electronic formats. This change would provide clarification and reflect current practice.

## Advice from the Advisory Committee on the Constitution

The Advisory Committee on the Constitution recommended that the 2 22nd General Assembly (2016) approve Item 06-15 for the reasons cited in the rationale.

The Assembly Committee on Church Polity and Ordered Ministry (06) voted to approve Item 06-15 59/0. The 222nd General Assembly (2016) approved the committee's recommendation by consensus.

#### 16-F. The Ministry of Members On Amending G-1.0304 (Item 09-11)

The 222nd General Assembly (2016) directed the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

Shall G-1.0304 be amended as follows? [Text to be added or inserted is shown as italic.]

"G-1.0304 The Ministry of Members

"Membership in the Church of Jesus Christ is a joy and a privilege. It is also a commitment to participate in Christ's mission. A faithful member bears witness to God's love and grace and promises to be involved responsibly in the ministry of Christ's Church. Such involvement includes:

"proclaiming the good news in word and deed,

"taking part in the common life and worship of a congregation,

"lifting one another up in prayer, mutual concern, and active support,

"studying Scripture and the issues of Christian faith and life,

"supporting the ministry of the church through the giving of money, time, and talents,

"demonstrating a new quality of life within and through the church,

"responding to God's activity in the world through service to others,

"living responsibly in the personal, family, vocational, political, cultural, and social relationships of life,

"working in the world for peace, justice, freedom, and human fulfillment,

"caring for God's creation,

"participating in the governing responsibilities of the church, and

"reviewing and evaluating regularly the integrity of one's membership, and considering ways in which one's participation in the worship and service of the church may be increased and made more meaningful."

#### **Background and Rationale**

This proposed amendment originated as an overture from the Presbytery of New Castle. The Presbyteries of Boston, Cascades, Heartland, Homestead, Inland Northwest, Lake Michigan, Monmouth, Northern New England, and Seattle concurred with the overture. New Castle Presbytery offered the following rationale:

Although a "green church movement" has long remained at the grassroots level in the U.S., the PC(USA) leads with a robust environmental ministry and "Earth Care Congregation" program. We recognize the importance of earth care issues and action, and we have an opportunity to add the concern to to an important section of our constitutional documents.

Membership in the Church of Jesus Christ and in the Presbyterian Church (U.S.A.) is a joy and a privilege. It is also a commitment to participate in Christ's mission. A faithful member bears witness to God's love and grace and promises to be involved responsibly in the ministry of Christ's Church. Caring for God's Creation is a critical act of faith in today's world and should be included in G-1.0304, "The Ministry of Members," of the *Book of Order*.

#### Advice from the Advisory Committee on the Constitution

The Advisory Committee on the Constitution advised the 222nd General Assembly (2016) that Item 09-11 presents the following matters the General Assembly should consider:

There are several points already in G-1.0304 that encourage church members to live out faithful stewardship of God's creation. The responsibility for caring for God's creation already is included in our confessional documents, as noted in the rationale, and this should be instructive for all church members.

The *Book of Order* is a constitutional document, not a manual of operations. Although there is no impediment to approving this overture, there is no compelling reason to add this to the *Book of Order*.

The Assembly Committee on Immigration and Environmental Issues (09) voted to approve Item 09-11 43/11. The 222nd General Assembly (2016) approved the committee's recommendation 429/120.



Financial Consultants Report:

- ↓ July-December 2016 [Draft Financial Results] Operating Ministry/Mission Fund:
  - The presbytery fiscal year financials detail a surplus of \$14,434 for the period ending 12/31/2016. Total resources (income) above budget \$28,749, and behind the prior fiscal year (\$23,524);
  - Shared Presbyterian Mission benevolences are above budget and the prior fiscal year period;
  - Per Capita partnership resources are tracking above budget and the prior fiscal year period;
  - Per Capita partnership receipts at 68% on 12/31/2016. This is roughly \$17k below the fiscal year budget estimates of a 73% receipts rate. Of this amount, \$7k is confirmed to be in the pipeline for payment by 1/31/2017. And if prior years' activity holds for this year, the presbytery will continue to receive 2016 remittances well into February;
  - At 50% of the budget year, ministry investments (expenses) at 48% or \$15k below budget and \$74k below the prior six-month fiscal period. Specific line items over runs to keep an eye on include; VL/SC Travel; Council/Assembly Events; and Staff Appreciation.
  - Presbytery Net Balance: Not including unrestricted balances designed for other projects, the presbytery net unrestricted fund balance (aka reserves) totals \$484,267 on December 31, 2016. Total unrestricted balances designated for other projects by Council total \$172,455. We've been informed of a material contingent asset relating to a pending presbytery land sale (currently awaiting zoning approval).

## Minutes of the Meeting of the Permanent Judicial Commission

## **November 15, 2016**

The meeting of the PJC was called to order following the Presbytery meeting by Linda Long, stated Clerk, on November 15, 2016.
