The effort to assist youth with disabilities in obtaining work experiences and quality competitive employment is filled with good intentions. Preconceived notions and the uneasiness which may be experienced when faced with a person or a situation with which you have had little previous exposure can create barriers that interfere with quality integrated and complete work experiences for youth with disabilities. Sensitivity training and sharing of effective strategies can go a long way in eliminating barriers of this kind and achieving greater outcomes. We will dialogue with our co-presenters and the audience, explore training for employers about working with people with disabilities, the challenges with early work experiences that both in-school and out-of-school youth face, and effective supports for students and youth throughout the pathway to employment.

Transitions is a program that assist youth and adults in transition to better understand their options so they can truly identify their own personal outcomes. We learned that people were being asked to develop goals based on their own desires yet many had no idea what that meant or could mean for them. These life skill sessions help them through actual experience to learn what they want, when they want and how much of it they can and should be doing for themselves – independent living and their rights and responsibilities lay the foundation and the rest coaches them to their true personal outcomes. Come see how you can add these services to your system as well.

10: Peer Advocacy and Mentoring

Young adults ages 15-24 who lack support in education, employment, housing and other basic needs find it difficult to make the transition to adulthood. As a result, some become disconnected youth – young people who are not working, in school or positively engaged otherwise. When youth remain disconnected from positive pursuits our communities bear the burden of a weaker economy, smaller tax base and higher expenditures on public benefits. We can enhance youth employment programs.

11: Achieving Community Readiness for WIOA Apprenticeships
