IDENTIFICATION REQUIREMENTS

(Taken from the Ohio Secretary of State website)

Please bring an original or copy of one of the following forms of ID which shows name and present address when appearing at a polling place on Election Day:

- ✓ An unexpired Ohio driver's license or state identification card with present or former address so long as the voter's present residential address is printed in the official list of registered voters for that precinct
- ✓ A military identification
- ✓ A photo identification issued by the US government or the State of Ohio that has an expiration date that has not passed
- ✓ Current utility bill
- ✓ Current bank statement
- ✓ Current government check
- ✓ Current paycheck
- ✓ Other current government document (other than a notice of voter registration mailed by a board of elections)

NOTE:

"Current" is defined as within the last 12 months. "Utility bill" includes a cell phone bill. "Other government document" includes license renewal and other notices, fishing and marine equipment operator's license, court papers, or grade reports or transcripts. "Government office" includes any local (including county, city, township, school district and village), state or federal (United States) government office, branch, agency, commission, public college or university or public community college, whether or not in Ohio.



ABSENTEE VOTING

What is an absentee ballot?

- o A ballot which is typically mailed to the board of elections prior to election day.
- o Ballots must be requested from county board of elections via mail or in person. Once received, the ballot must be completed and mailed or returned in person to the county board of election by election day.
