- Actions reflect her passion & personal commitment of time, talent or treasure on behalf of others.
- Has demonstrated leadership in coordinating volunteer efforts of individuals or groups for fundraising, special events, programs or services that benefit the community.
- Has inspired others to get involved, take responsibility, or assume leadership in order to effect positive change.

### **Eligibility:**

Nominee must be a female who either resides, works or whose impact has been felt in the Greater Danbury region - Bethel, Bridgewater, Brookfield, Danbury, New Fairfield, New Milford, Newtown, Redding, Ridgefield and Sherman.

### **Nomination Submission:**

- Completed Nomination Form
- A letter of support describing 1) how the nominee meets the selection criteria, and 2) specific details about the nominee's contribution and those who have benefitted.
- Letter(s) from at least one other individual(s) in support of the Nominee.
