

# WHY AGRIBUSINESS?

**Over 45% of military recruits come from rural communities - and return to those rural communities after service - so it is in the U.S. economic and national security interests to enable small business ownership in agribusiness; and for the Veterans Business Outreach Centers (VBOCs) to provide training, counseling, networking and access to capital to support their endeavors.**

Within the agriculture industry, "agribusiness" is used simply as a portmanteau of "agriculture" and "business"; referring to the range of activities and disciplines encompassed by modern food production and distribution. There is vocational training and academic degrees in agribusiness; as well as agribusiness trade associations, agribusiness publications, and so forth, worldwide.

The U.S. agriculture sector extends beyond the large farm business to include a range of farm-related industries and agriculture supported economies. The term "agribusiness" most often emphasizes the "interdependence" of these various sectors. Taken broadly, agribusiness includes the business sectors that support, and are supported by, agriculture. Restaurants and breweries are obvious examples, but so too are small town barber shops, hair and nail salons, day care centers, coffee shops and bookstores that serve the local (albeit mostly rural) communities. But agribusiness isn't restricted to rural areas – roof top gardens, vertical farms, beekeeping, aquaponics and hydroponics, composting, farmer's markets and farm-to-table initiatives, etc., make this an urban endeavor as well.

Agriculture and agriculture-related industries contributed \$985 billion (or 5.7%) to the U.S. gross domestic product (GDP) in 2014. The output of America's farms contributed \$177.2 billion of this sum - about 1 percent of GDP. The overall contribution of the agriculture sector to GDP is larger than this because sectors related to agriculture - forestry, fishing, and related activities; food, beverages, and tobacco products; textiles, apparel, and leather products; food and beverage stores; and food service and drinking places - rely on agricultural inputs to contribute added value to the economy. Additionally, 17.3 million full- and part-time jobs were related to agriculture - 9.3 percent of total U.S. employment. Direct on-farm employment provided over 2.6 million of these jobs. Employment in the related industries supported another 14.7 million jobs. Of this number, food services and drinking places accounted for the largest share - 11.4 million jobs - and food/beverage manufacturing supported 1.8 million jobs. The remaining agriculture-related industries together supported another 1.4 million jobs.
