- The nominee demonstrates activities that assist technology clients or companies in North TX in improving results or accelerating and/or enhacing business performance.
- The nominee has demonstrated leadership in the technology community in North TX.

## As part of the selection process, nominations will be judged on the following criteria:

- How the nominee has demonstrated leadership in the technology community. (50%)
- The activities of the nominee within the technology industry, and examples of how the nominee assists clients or the community in improving results or accelerating and/or enhancing its business performance. (50%)
