



2018 USHJA Emerging Athletes Program 3' Section Application

The Emerging Athletes Program was created specifically to provide opportunities for young riders to advance their education as they strive to become knowledgeable horsemen within the hunter/jumper community. When EAP Regional Training Sessions do not fill, it provides us the opportunity to offer the same experience to riders not meeting the EAP criteria, and a 3' section is offered. The curriculum and activities provided are the same as for 3'6". Other than the heights offered, the other primary differences between the two sections are:

- Applicants for 3' sections will be accepted on a first come/first serve basis;
- And participants are not eligible to be chosen for that year's EAP National Training Session.

Riders may be required to present health documents for their horses upon arrival at the Regional Training Session, e.g., valid Coggins, health certificate and/or proof of current vaccinations as required by each host facility.
