## EUROPEAN TOUR SCHOLARSHIPS

Members of Concert and Principal Orchestras are eligible to register for the Italy 2020 tour.

It is our goal to have as many of our Principal and Concert musicians join us for this wonderful opportunity. Partial scholarships will be awarded from the Cameron Bruce Memorial Scholarship fund and in funds received from the family of Chic Goldstein.

Each family is to complete a European Tour scholarship application and the student is to write a one page essay answering one set of questions below:

- Students new to the NYS Performance Tour Experience -  
“What I expect to gain from an International Performance Tour” **and** “How music has made a difference in my life”.
- Students who have traveled with NYS on a previous Performance Tour-  
“What was one thing that affected you the most from a past tour and why” **and**  
“Being a past tour participant, what advice can you give a new participant”

Each musician will also have the opportunity to reduce the cost of his or her own individual trip by selling raffle tickets for the trip to Paris/London. For each \$25 raffle ticket a student sells \$20 will be credited toward their trip and \$5 will be used to offset the group’s expenses.
