Dear Parents and Guardians,

The Senior/Junior Prom of Saint Basil Academy begins promptly at 7:00 p.m. on April 28, 2017 at Philmont Country Club, Huntingdon Valley, PA. To insure a lovely evening for all participants, we are asking all parents/guardians to partner with us in reinforcing the following prominstructions.

Since the prom is a school-related function, adherence to the Code of Conduct and Dance Policy are of utmost importance. We ask all parents/guardians to review St. Basil's Code and policies with their daughters before the event takes place, so that parents and students are aware of the consequences for breaking any policy.

Parents should sign the prom directives form, including escort information, and the student should return the form to Mrs. Fina. Ladies will present their escorts to the prom moderators before being admitted to the ballroom. If any attendee appears to be under the influence of any illegal substances, you will be notified immediately and asked to pick up your daughter. The parents of your daughter's escort will also be called. If this unfortunate event occurs, students may be dismissed from the Academy, and seniors may be denied graduation with their class. No one may leave the ballroom between the hours of 7:00-11:00. If circumstances warrant an attendee leaving, a security guard will accompany the person to his/her car. Should this occur, you will be notified.

Dinner will end at 9:00 p.m. followed by dancing until 11:00 p.m. Couples are expected to display standards of behavior in accordance with the SBA Dance Policy. If chaperones observe unbecoming behavior, a warning will be issued after which parents will be called to come and pick up your daughter/escort. Please understand that chaperones are present to insure that social proprieties are observed throughout the evening. The goal of the SBA administration and chaperones is to provide a safe and memorable evening for your daughters.

Your daughter and her escort will leave Philmont Country Club at 11:00 p.m. At the conclusion of the prom, parents are responsible for the safety of the couples. The school does not recommend post-prom celebrations, and the pre-prom assembly will focus on enjoying the prom experience responsibly. We ask for your support in discouraging the use of any illegal substances and to encourage a climate of safe and responsible behavior.

Please sign the slip below and return it to Mrs. Fina in room 20 by Tuesday, April 25. If the form is not returned, your daughter is not allowed to attend the prom. Thank you for your cooperation.

Prom Directives 2017

- 1. The Saint Basil Academy Code of Conduct and Dance Policy will be enforced.
- 2. Any Saint Basil Academy student who comes to Prom intoxicated, exhibits any indication of drinking, drinks during the dance, or shows signs of drug use, may be expelled.
- 3. Escorts are expected to adhere to the same rules outlined above for Saint Basil Academy students.
- 4. Students should provide the name, address, and phone number of their escort to Mrs. Fina. Escorts must be under 21 and may be asked to present ID upon entrance to the prom.
- 5. Parents should sign the attached letter and pledge. Students should return all Prom forms to Mrs. Fina by Tuesday, April 25, 2017.
- 6. One's dress should reflect the Christian values instilled at Saint Basil Academy. Failure to respect the dress code may result in disciplinary action. The decision will be made at the discretion of the chaperones.
