Evelyn discussed training camp judge volunteers:

- -issue is too many judges to find volunteer positions
- -implementing proposal from Cookie and accepted by Region 8 Committee in 2019.
  - -small groups with ipad to view slow-mo videos on site
- -must send to all registered athletes and post on site signage to notify parent/coaches/gymnasts of video use during camp so they may opted out if they want.

Application for judges to volunteer for Region 8 Training Camps will be sent to judges in Eastern/DP National rotation first. Reasoning is judges on Eastern and DP national rotation are required to attend Region 8 Level 8/9/10 or National Team Training Camps. If judges do not sign up, they will still be able to attend but will pay registration fee and receive In Gym experience.

Application to register will be sent to Brevet and National judges on May 15<sup>th</sup> (after Regionals and Nationals). Registrations due June 1<sup>st</sup>. After June 1<sup>st</sup>, any open volunteer positions will be to rest of judging community for registration.

# Brevet/National Judges rotation:

The Brevet/National judges rotation for Eastern and DP Nationals was reviewed. Alternates and TBD positions were decided by draw. Updated assignments will be sent to all judges in rotation for Eastern and DP Nationals.

# <u>Timeline for judges into Eastern/DP National assignments</u>:

Next summer is judges testing/recertification.

Applications will be sent out in September 2022 for present and additional judges from group 3 to apply to be added to Brevet/National judges rotation for Eastern and DP Nationals.

Application must be returned in November 2022. Region 8 Committee will make selections in December meeting of 2022 for 2025 – 2029 Brevet/National judges rotation.

Reasoning: this will give judges year of 2023 to get their criteria met for consideration.

Judges who want to judge 2023 Regionals must still turn in completed Session Tracking and In Gym Cards with Judges Availability Form to RTCC and RJD between April 1, 2022 and May 1, 2022 to be eligible to judge any 2023 Region 8 Regional Competition Regional Availability.
