IRPF was founded in 1992, with the support of the National Association of Realtors, in response to the need to create and cultivate property markets in the former Soviet Union.

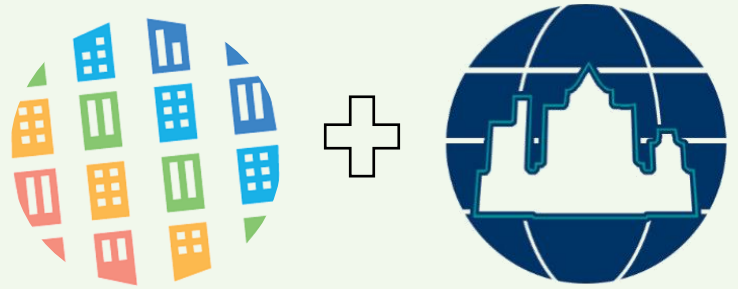
IRPF focuses primarily on developing the institutions and practitioners critical for real estate markets to effectively function, and has completed programs in over 20 countries.
