H) What other conditions that should be considered?

- No mandatory masks! Take Self responsibility people!
- Our health is a personal responsibility. You're basically making citizens criminal if they dont obey. This is a slippery slope. We need to be encouraged to do the right thing and educated not forced into mandated paper masks.
- Provisions should be made for proper disposal of PPE
- My primary concern about masks is that people have stopped physically distancing and stores are no longer monitoring occupancy. While masks are beneficial, the key advice from Dr. Hinshaw remains that physical distancing is the most effective means of combating the spread, masks are just an additional layer of protection. I would like to see that physical distancing measures be reinforced or reinstated. Beyond that, I would suggest the age of the person needs to be considered, masks on young children should be exempted. I am in agreement with masks to a point, however, as a hearing impaired person I am really struggling to communicate and function in places where people are wearing a mask. Perhaps mandating that key workers wear a mask with a clear front thereby facilitating the hearing impaired community.
- We should stop making exceptions and be looking at creating workable structures. Such as restaurants, we don't need an exception for people to not be safe. We need a workable structure of how to maintain safety and eat.
- If this is implemented, what are the parameters and scientific reasoning for such; and when will the bylaw be removed - what is the measure to meet to remove the bylaw?
- Staff should be provided with masks, sanitizers, etc. and their use is up to the discretion of the staff member. Sanitizers should be made available for customers
- Esthetics services on faces need to an exception
- I believe that Council should pass a bylaw requiring the use of face coverings in all indoor public spaces, not private indoor spaces.
- Asthma and other reparatory issues

- City should consider providing free masks to businesses
- If someone really doesn't want to wear a mask, I wonder if a ventilator would be more comfortable. I have a shop where I supply masks and sanitizer at the door. I require the customer to conform. The safety of my staff is important. My shop is in Calgary but the issues are the same.
- There should be exceptions for individuals who have health issues that are exacerbated by mask wearing, as well as age minimums. If masks are mandated, they should only be mandated for workspaces where the 6-foot space is not available.
- Indoors for masks apply to businesses
- it needs to be up to the person if they choose to wear a mask not the government or business there
- masks should be supplied by the city or government that implements the policymaking, and exceptions for those with medical issues, also any health conditions in future that result from forced mask policymaking is subject to legal proceedings and even class-action suits
- People who cannot wear masks for long times due to health reasons such as asthma. No one has offered any information on the Carbon dioxide levels that we exhale and then re inhale when limited to mask wearing which in turn lowers our oxygen levels. This has negative impacts on anyone that is affected by lower oxygen levels in their body. Asthma is easily induced under these conditions. Possibly many more conditions.
- In situations where you can certainly maintain physical distance (eg. inside an individual office within a business) that person should be able to take their mask off, when in the office alone. If anyone else enters the space, the mask should then be put in place.
- Exceptions for dining are appropriate, but not exercising. Exercising is one of the times people should be using a mask given the risk of droplet expiration.
- In addition to mask and physical distancing, they should be educated on proper hand hygiene.

- I don't think people wear masks properly in general which impacts how effective they are. I also don't think business owners should be responsible for policing it. It puts them in a difficult position and is not their job. It is also contradictory that masks are not required in restaurants due to eating and drinking but are required elsewhere. Obviously they can't be required when eating and drinking but to force someone to put it on to go into the grocery store then take it off when they get to a restaurant makes no sense.

- At the end of all of this, we will only regret the steps we did not take. I get you are trying to listen to all people's opinions, foresee results, and it delays taking action. I invite you to take decisive action and notice the result.
- The research says masks will ONLY work if everyone maintains 6 feet apart and washes there hands and take all the other precautions. I've seen people throw parties or bbqs where you have to wear a mask. If you do not keep 6 feet apart, the masks are mostly ineffective. I think masks give people a false sense of security, and will ultimately lead to more infections unless they are properly educated that a mask is not a sheild.
- Be careful - this allows criminals to be braver, as they can cover their face, head and eyes (with sun glasses) and there is no way to identify them. This worries me for the safety of my team.
- We are not in favour of a mandatory mask bylaw.

We are already enforcing masks upon entering the studio and exiting but not while working out. If it was to be enforced while exercising, I would lose members and be concerned for their safety even more.
- I feel that most people of Airdrie are already taking independent precautions and acting safely. I think for Airdrie to implement a mandatory mask bylaw the number of active COVID 19 cases should reflect the immediate mandate, right now I feel the active number of cases are low

enough to reflect the impact of the measures the population has already been taking. Free will is powerful. I think an educational media on benefits of mask wearing would naturally encourage more people to respond accordingly.
