Dear Friends,

Last night, Mayor Garcetti announced that the City of Los Angeles is moving into the next phase of the City's [Safer At Home](#) reopening plan that includes a careful and deliberate roll out to make it as safe as possible moving forward.

Here's the good news:

He announced that as of today (Wednesday) all retail establishments may reopen for in-person shopping at 50-percent capacity. Every store will have to adopt County [safety protocols](#) to ensure the safety of workers and customers, alike. **This does NOT yet include personal services like hair salons, nail salons, and barbershops. It also does NOT yet allow for dine-in services at restaurants.**



Also, houses of worship are now allowed to open at either 25% or 100 person capacity (whichever is fewest). Download a [Safer LA: Tool Kit for Houses of Worship](#) here.

Now here's what could be the bad news:

We need to proceed carefully and deliberately or it could bring a flurry of new cases, more deaths, and a possible shutdown again. This is not what anyone wants to see.

Please make the choice to protect yourself, your family, and your neighbors. Remember, if we all run to the beaches and don't follow the protocols; if people walk around in public not wearing masks; if we go to religious services without a mask and social distancing; then we will backtrack on the progress that we have made toward recovery. The outcome is up to everyone.



*The most important way to make sure things continue to improve is for everyone to strictly adhere to the City's face covering rules when they leave their homes and will be near other people. **It is the single most important barrier to aid in the fight against COVID-19.** Wearing a mask is even more important as retail and business restrictions are gradually eased.*
