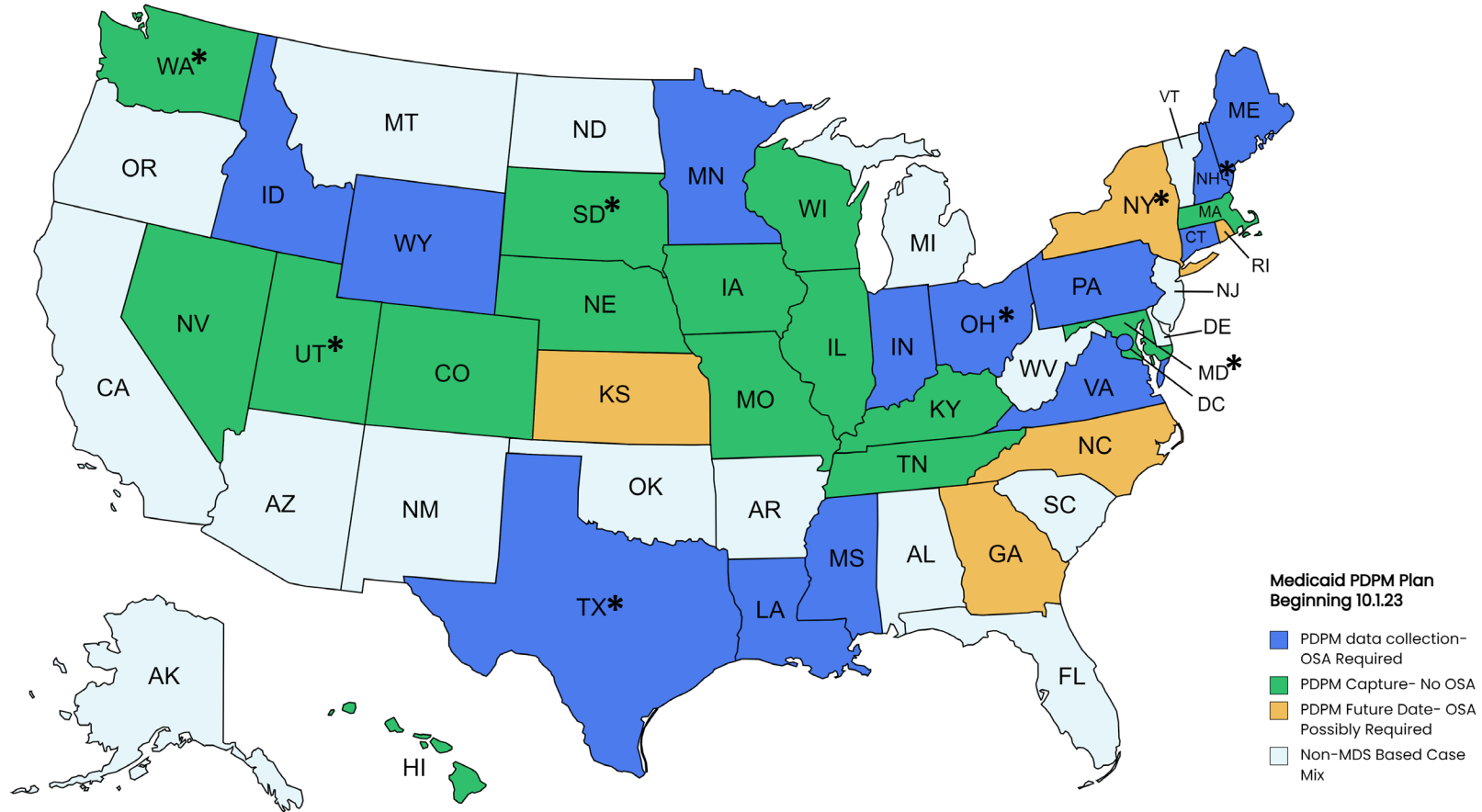


State Case Mix Map 10/1/2023 Plan

- NY: RUG CMI rates frozen through 2024; unknown plan for PDPM
- OH: Providers may choose to freeze RUG CMI rates; or continue with OSA to update
- SD: Legislation still pending for implementation of PDPM (7/1/2023)
- TX: OSA not required, states must submit data elements through Texas portal system
- UT: PDPM payment, but using OSA for Upper Payment Level
- WA: RUG CMI from Q3 projected through 7/2024; PDPM rates to follow
