

HOW TO VIRTUALLY PARTICIPATE IN THE LEGISLATIVE SESSION

FIRST, VISIT [LEG.STATE.NV.US](https://leg.state.nv.us)

Click on "Scheduled Meetings" on the upper right-hand corner.

TO SUBMIT AN OPINION...

Click Submit an Opinion

You'll select the bill you want to comment on, choose whether you are in favor, against, or neutral regarding the bill, and if you want, you can include a short comment on your reasoning.



It will ask for some of your personal information to determine what legislative district you're in. This will never be made public or shared.

Once you fill out the information, hit the blue Submit button- you're all done!

TO SUBMIT PUBLIC COMMENT...

Select "Participate" on the "Additional Meeting Details" section.

It will take you to the Meeting Participation page, where you'll need to fill in some basic information. Then you will select whether you wish to comment on a specific agenda item, or just make a general public comment.

Are you here for an agenda item or for public comment?

You may sign in for both. Select "Public Comment" for general comments not related to a bill or budget on the agenda.

Or if you'd rather not talk...

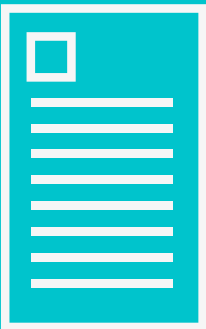


*Quick Tip

TO SUBMIT WRITTEN TESTIMONY...

Check the Agenda



At the bottom of every agenda, there are instructions for how to submit written testimony. Craft your statement, then send it to the listed email on the agenda as soon as possible. Here's an example from a Senate Education agenda.
